We really would like more information concerning this matter if you can secure it. We wonder if any legal action is going to take place and if any charges were made by the Scout or the family in court.

The statement of one individual against another is very difficult to substantiate, especially if several years go by and neither you nor I are on our present jobs. This would make it very difficult for someone else to refuse registration should an application come in from another council.

Any statements from other individuals or legal convictions would be most helpful.

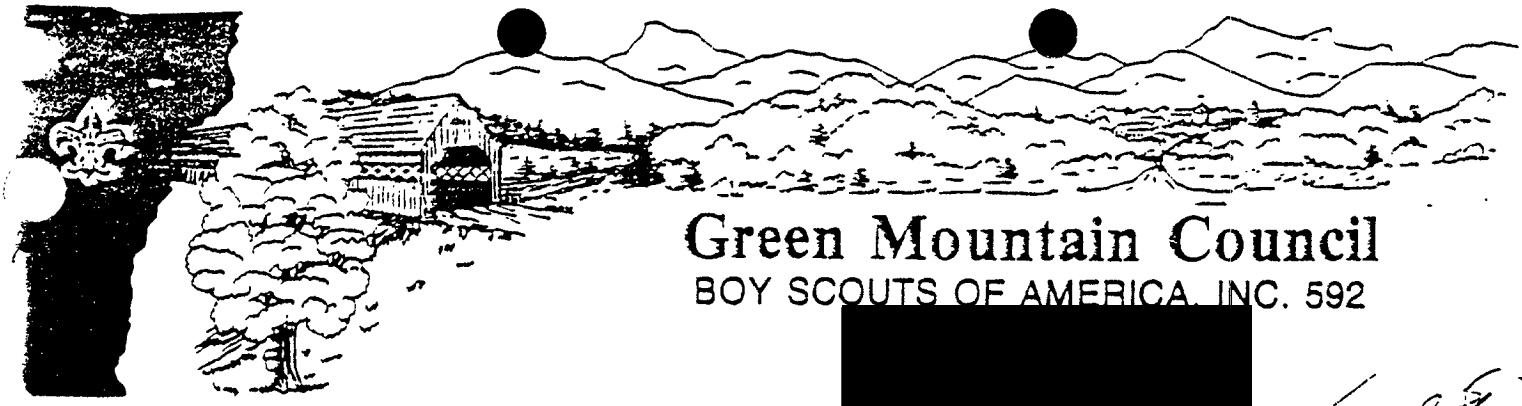

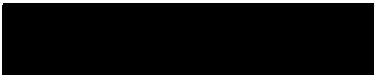
