

THE FOLLOWING INFORMATION IS PROVIDED SHOULD UDESIRE A REVIEW BY THE SOUTHEAST REGION, BSA, OF THE DECISION TO DENY YOUR REGISTRATION.

- 1. Within 60 days, you must request in writing a review of this decision. Your request should be sent to Southeast Region, Boy Scouts of America, P. O. Box 440228, Kennesaw, Georgia 30144. In your request you must include your version of what occurred in support of your claim that registration should not have been denied.
- 2. Upon the receipt of your written request, a committee will be appointed to review the situation.
- If the regional review committee determines that a review hearing is necessary, the committee will advise you whether or not you may attend. In some instances, no useful purpose would be served by having the applicant present. The hearing is not adversarial in nature and neither the committee nor you, if you attend, will be represented by legal counsel. If you wish, in the event you attend, you may be accompanied by not more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4. The committee will review the facts as presented, an may interview any persons who testimony might assist them in arriving at a correct decision.
- 5. You will receive a letter setting forth the decision of the committee.
- 6. If you are dissatisfied with the decision of a regional review, you may request a further review by the National Council. The decision of the National Council will be final.

Memorandum of telephone conversation with on November 9, 1991.
birthdate is . He told me of five (5) occa- sions where Danny Kennedy gave him backrubs. Two (2) at the lakehouse of . one)1) at the home of . one (1) at Philmont, and one (1) at the Maine High Adventure Base.
The first occurred at an OA training outing at lake-house. He was 15 years old (1985). Danny Kennedy talked quietly to him and asked if he wanted a backrub. It told him okay. Then became uncomfortable and asked Danny to stop. Dan immediately stopped.
The second incident occurred at sleeping bag next to be not the floor. He again spoke quietly to him and began to give him a backrub. The backrubs would go to lower body parts. Said he fell asleep and turned over on his back and awoke, sat up and began to cry. Danny Kennedy was doing oral sex on his penis. When cried, Danny left him and went to his own sleeping bag. The next day nothing was said and nothing more happened.
The third occurred at the gave him a backrub and then Danny asked give him a backrub. Gave him a backrub and then Danny asked if he wanted a backrub. Said that he could sense this was leading to oral sex and told Danny to stop and he did.
On the Maine trip, the first night was spent in a large room. said they slept on the floor. He said he woke up and saw Danny Kennedy giving a backrub and frontrub.
On the Philmont trip, Danny took the crew off the trail. The bus took them to Raton (entire crew). Returning, there was bus trouble and the entire crew spent the night in the St. James Hotel in Cimarron, New Mexico. did not go into details as to what took place in the room.
told me that he "pushed it off" and "did not wish to deal with it." He told me that got him off to the side and told him to "watch-out" for Danny Kennedy. That he "liked" and him (). He said Danny could always arrange to "tent" with kids he liked.

told me that on one occasion he started to tell Paul Lee about what went on but decided against it. He later told Mickey Washburn and Mickey reported to the Unit Commissioner, who reported to the Scout Executive.

further told me that prior to all this that he experienced "problems" in Troop 695 with Dave Minter (ASM). Dave Minter told lies. He said that he was a doctor and would undress kids. He was asked to leave by the Committee. He would also give backrubs, pay for stuff and try to get kids to go out after meetings with him.

asked that this information be kept confidential. He does not believe that Scouts should have to experience what he has gone through. He does not wish to be further involved with this matter. He expressed that Scouting is a very important part of his life and he hopes to continue as an adult leader after college.

SUMMARY MEMORANDUM

On March 11, 1991, Mickey Washburn, Scoutmaster of T-695 met with Scout Executive Archie Crain and me at 3:15 p.m. in the Scout Executive's office. Mr. Washburn reported to us incidents reported to him by his Assistant Scoutmaster, involving Dan Kennedy.

Mr. Washburn reported that had told him that in 1986, 7 adults and 17 Scouts were going to the Florida Sea Base. Five spent the night at Washburns home. Dan Kennedy and spent the night in the living room. Dan Kennedy slept on the floor and slept on the sofa. Solicitation for sex took place in that room.

In 1987, solicitation also took place in San Antonio on a Philmont trip and also on a trip to the Maine High Adventure Base.

Mr. Crain asked Mr. Washburn to have to call him. Tried on two occasions to contact the Scout Executive, but would not leave a number for a return call. did call me at home on the evening of November 9, 1991.

I made notes of the November 9, 1991 conversation (separate memo). On November 13, 1991, I met with Steve Kinnard, Chairman of the Council Youth Protection Committee. Mr. Kinnard reviewed the information as reported to me and recommended that steps be taken to place Mr. Kennedy on the Ineligible Volunteer Record and report our information to Mr. Bob Wilson, DeKalb County District Attorney.

I talked with Mr. Wilson by phone on Friday, November 15 and he requested that I send him copies of the information we have regarding this matter.

On Monday, November 18, 1881, a registered letter was mailed to Mr. Kennedy, refunding his membership fee and informing him that his membership had been denied. Letters were also mailed to the Heads of the four (4) units where Mr. Kennedy was registered.


