Under terms of a pleasing agreement, the Warren County Prosecutor's Office will follow the recommendation of the state diagnostic center for treatment if Meyer's conduct is found to be that of a compulsive and repetitive sex offender. Otherwise, a jail sentence not to exceed five years will be recommended.
