The final hearing took place in mid December. Mr. Mink pleaded 'no contest' to the charges of child molestation. He received a one-year suspended sentence with mandatory counseling and five year's probation.

Teacher faces charges of sexual assault

A 58-year-old teacher at Roger Williams Middle School in Providence has been charged with second-degree sexual assault on two 12-year-old boys who are students at the school.

Albert E. Mink of Rocky Hill Road, North Scituate, who teaches social studies and conducts school leadership classes for boys, allegedly committed the assaults at Camp Yawgoog, a Boy Scouts facility in Hopkinton, on May 1, according to court records.

Mink for many years was assistant camp director. He resigned that position last Sunday, according to Vincent N. Borrelli, scout executive and secretary of the Narragansett Council, Boy Scouts of America.

Mink was arraigned yesterday in District Court, South Kingstown. He was released on personal recognition by Judge Michael A. Higgins.

Providence Supt. Joseph A. Almagno said Mink, who is scheduled to retire next month, has been assigned "administrative duties" and will have no contact with students for the remainder of the school year.

Mink has "called in sick" since last Friday, when he was questioned and arrested by state police, Almagno said.

According to the affidavit from state police Lt. John E. Turner, the alleged assaults occurred during an overnight outing at the camp. Parents called police after the boys returned home the next day.

Mink is a veteran teacher and has held a number of Providence school administrative jobs, including the principalships of Oliver Hazard Perry Middle School, Nathanael Greene Middle School and Samuel W. Bridgham Middle School. He has long been active in a program that conducts physical fitness and leadership classes for boys, according to Almagno.

We received information concerning the above-named individual. It was indicated that he had been charged with child molestation.

We have not heard from you concerning this matter and wondered if you had any additional information which would be helpful to us in establishing a file. We feel, at the present time, that we should start a file and suspend any registrations until this matter is cleared up.

I am enclosing a Confidential Record Sheet which I would like to have completed so that we may identify Mr. Mink should he try to register in some other location.

We also would like to have a copy of the resignation if you have this in writing. Any newspaper clippings or police records would also be most helpful in substantiating our refusal of registration attempts.

THE FACTS:

Al Mink, currently employed part-time as reservations director for the Yawgoog Scout Reservation, has been charged by the Rhode Island State Police with several counts of child molestation.

While details are sketchy, Mink supposedly was at the Scout Reservation with two boys, age 11, the weekend of May 2 when the incidents are said to have occurred. Mink is a school teacher and the youths were students (non-Scouts). The charges were filed by the families of the two boys.

Mink, married, late 50s, with grown children, maintains he is innocent, but he has resigned his BSA position "for the good of the council." He had been employed at Yawgoog since 1947 either as camp director or in a reservations position.

ACTION OR RECOMMENDATIONS:
