I am forwarding to you some information on JAX DOUGLAS MITCHELL of Grants Pass who was arrested on June 27, 1985 and charged with several counts of sodomy and sexual abuse involving young children. At the time of his arrest Mr. Mitchell was registered as an assistant varsity team coach with Team 90 sponsored by Church of Jesus Christ of Latter-Day Saints, Grants Pass Second Ward.

As you can see from the enclosed reports marked CONFIDENTIAL Mr. Mitchell pled guilty to eight separate charges of sodomy and sexual abuse on August 14, 1985.

On February 12, 1986 JAY DOUGLAS MITCHILL was sentenced to a total of sixty years in prison with a minimum of thirty years. Obviously, I recommend that he be denied registration with the Boy Scouts of America and the proper steps be taken to ensure that he can not register in the distant future.
