Blackfoot day-care hearing postponed

BLACKFOOT — A public hearing on a new day-care ordinance for the city of Blackfoot has been postponed until Sept. 19.

The hearing was originally scheduled Sept. 5.

City Clerk Don Wren said it was moved to the later date to coincide with a public hearing on a new comprehensive plan for the city.

The public hearing for the 1989-90 budget is still scheduled for Sept. 5, at 7 p.m., Wren said.

Man pleads guilty to lewd conduct

REXBURG — A Rexburg man has pleaded guilty to one count of lewd and lascivious conduct with minor children in a plea bargain that resulted in the dismissal of three other felony charges.

Jared Chabot Murray, 45, of 326 W. Third South, pleaded guilty to a charge of lewd conduct with an 11

year-old.

According to court records, Murray originally was charged with three counts of lewd and lascivious conduct and one count of sexual abuse of a child. The charges involve four children under the age of 16.

Bail has been set at \$100,000, but Murray has been released from the Madison County Jail so he can continue to work.

Sentencing has been scheduled Sept. 25.

Bomb threat clears complex

FORT HALL — Business at the Fort Hall Trading Post Complex was disrupted Wednesday evening when a telephoned bomb threat resulted in evacuation of all buildings.

A dispatcher said police determined the call was a hoax following an hour long search of the complex.

The dispatcher said a waitress at the Oregon Trail Restaurant took the call shortly after 6 p.m., saying it sounded like a young person.
