On Tuesday, August 9, 1988, Larry Van Pelt, Scoutmaster of Troop 12, Berwick, Louisiana, notified me of the following facts. [REDACTED], father of 16 year old Boy Scout [REDACTED], had intercepted and copied a letter from Bea T. Oubre to [REDACTED]. This related to a sexual involvement that had existed since February, 1988. I asked for a copy, on advice of our Council Attorney. A copy is enclosed, in envelope from [REDACTED].

[REDACTED] told me his only interest was to sever the relationship, not to cause legal problems for Mrs. Oubre. To my knowledge, her husband and family are unaware of this matter. He told me that [REDACTED] had asked Mrs. Oubre to break it off with [REDACTED].

Troop 12 was planning a trip to Pensacola, Florida August 12, 13, 14, 1988. Mrs. Oubre was going to assist with transportation. The Troop Committee Chairman asked her to take no part in Troop activities. The Scoutmaster called her, not knowing this, and asked her not to go with the Troop. She told him she was resigning from all Scouting activities and was sorry if she had caused any problems. She also told him she would write to me. These letters are also enclosed.

I have written to her suspending her registration, and am returning her registration fee.

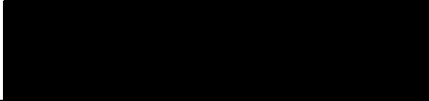


Dear Bea:

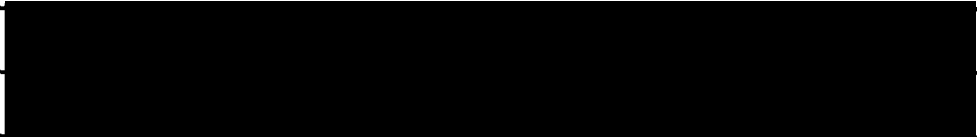
