# Ex-scoutmaster guilty of raping Md. boy, 11

A former scoutmaster from Elkton, Md., has pleaded guilty to the statutory rape of an 11-year-old Boy Scout on a March weekend camping trip in Chester County.

David M. Pennington, 41, was sentenced Wednesday to five years' probation in a plea bargain before Chester County Judge Charles B. Smith. Smith also ordered Pennington to pay a \$500 fine and to undergo psychiatric treatment.

The judge also barred Pennington, who, according to court documents, had been active in the Little League for 14 years, from serving in a supervisory capacity in activities involving children.

Pennington faced a maximum sentence of 10 years in prison and a \$15,000 fine. He had remained free on bail since his arrest March 20.

Court documents said Pennington

had engaged in oral sex with the boy, who also lives in Elkton, after the youngster went into Pennington's tent to keep warm during the night of March 3. Their scout troop was camped at a farm along Barren Road in Elk Township, Chester County, just north of the Maryland border.

In a May letter to the court, the boy's mother said her son was hysterical when he returned home from the camping trip and required psychological counseling.

In court documents, Pennington's attorney contended that the boy had made up the story to reunite his separated parents.

The prosecutor, Assistant District Attorney Timothy Tietze, said the victim's family had not sought to have Pennington jailed.

"They wanted him helped," Tietze said. "Their main concern was that the child be vindicated."
