Dear Paul:

Please find enclosed information which you and I discussed by telephone. We were notified by law enforcement that Gary Brian Phillips automobile was stopped and he was questioned on suspicion of attempting to lure children into his car near an elementary school. Their suspicions are strong enough that they anticipate he will be charged with the offense. He is single, and in his home they found numerous childrens toys and games. There was some indications that he may have exhibited this pattern of behavior in other communities previously.

At the time of his detainment, the officers observed a Boy Scout leader application in his vehicle. We were asked by the officials if we know of this individual. We haven't found any connection but will be on alert.

In addition to the enclosed information, we submit the following:

Mr. Phillips stated to the officers that he was an Eagle Scout.

It is our opinion that Mr. Phillips should be placed in our system as NOT worthy of membership in the Boy Scouts of America.
