As you will note by the attached letter from District Executive John Rice, this situation has been complicated by the fact that Mr. Powers was called up by the U.S. Army, and has not yet returned.

There is some doubt, also, about the validity of the charges made against him. Yet in Rice's interview with him, and in the Powers letter to Rice, there is no denial of the fact that Powers violated BSA leadership guidelines.

The Chairman of the Troop Committee is a Police Detective. We are getting our information directly from him. As of June 19, 1991, we have nothing further to add.

The District Attorney's office is waiting to prosecute this matter until Mr. Powers returns from active duty with the Army. He is currently stationed in California, and still has a chance of being sent to Saudi.

My contacts tell me that he has been home once on leave for about ten days. Other than that, he has not been in the area, and a warrant has not been sworn.

It appears that when he does return, charges will be filed then either dropped or reduced. The boy's family has moved from the community they were in and changed schools.

When I spoke with the detective, he indicated that there have been some story changes but was not yet specific. The file is not available to us until the case is either dropped or resolved. At that time we will have full access to the files.

This morning, I spoke with Ed Liebrecht, CC of pack 160. Last night he visited Mr. Powers. Based upon the information he gave me today and at his request, I believe that we are now obligated to suspend John F. Powers from the Scouting program.

Yesterday, (1-9-91) Mr. Powers was visited by detectives from the Vice Squad. He relayed parts of the conversation to Mr. Liebrecht.

The youth in question was picked up from his home and transported to the Powers' residence to play with Mr. Powers' by John Powers. When they arrived at the Powers' residence, the family was not home. Mr. Powers gave the boy a tour of the home. They ended up in the parents' bedroom where the two sat on the bed and played a Nintendo type game. After a few minutes, the boy noticed a stethescope accross the room and asked about it. Mr. Powers asked the boy if he wanted to listen to his (own) heart beat. Mr. Powers helped him listen to his heart, then to his belly. Then, according to Mr. Powers, the head of the stethescope dropped and when he reached for it, it touched the tip of the boy's penis. Mr. Powers added "I didn't fondle him."

They then went downstairs and a few minutes later the family returned. The boys played for a short while before the visiting boy had a case of diahrea. Mr. Powers then took the boy into the bathroom to clean him up and furnish him with a set of clear clothes.


Mr. Powers is scheduled for another conversation with the Vice Squad this week and will see the District Attorney next week.

By profession, John Powers is a Physician's Assistant, although he has not been employed for approximately five years. He is a member of the Army Reserve (Unit unknown). His wife's name is and they have two children:

is employed by the Veteran's Administration (as a Dentist?) John's last known employer was also the Veteran's Administration at a hospital in California. Until recently he had been furthering his education at UWM. He is just short of his Master's Degree.

The following information is provided should you desire a review by the East Central Region, BSA, of the decision to deny your registration.

- Within 60 days, you must request in writing a review of this decision. Your request should be sent to the Regional Director, East Central Region, BSA. In your request, you may include your version of what occurred in support of your claim that your registration should not have been denied.
- 2. Upon the receipt of your written request, a committee will be appointed to review the situation.
- 3. You may attend the review hearing, but it is not adversarial in nature and neither the committee nor you will be represented by legal counsel. If you wish, you may be accompanied by no more than two other individuals if their testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4. The committee will review the facts as presented, and may interview any persons whose testimony might assist them in arriving at a correct decision.
- 5. You will receive a letter setting forth the decision of the committee.
- 6. If you disagree with the decision of the committee, you may request a review of this decision by the National Council of the Boy Scouts of America.
