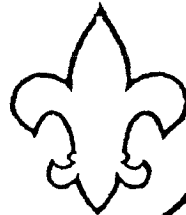

C.R. man receives 5-year sentence on reduced charge

[redacted] has been ordered to serve a sentence of up to five years on a reduced charge stemming from contact with the genitals of an 11-year-old boy early last year.

Cedar Rapids

The 41-year-old Cedar Rapids man had been charged with two counts of third-degree sexual abuse, which carries a 10-year sentence. He pleaded guilty to a charge of lascivious acts with a child, which carries the five-year sentence.

Judge [redacted] said [redacted] "desperately needs" psychiatric or psychological counseling and that it is necessary for him to be confined for the protection of the community.

Previous incidents of similar activity were discussed during the sentencing hearing in [redacted] court Thursday.

The judge said both the objectives he talked about, counseling and protection, would be best served by having [redacted] placed in a state facility at Mount Pleasant.

The place where the sentence is served is determined by the director of the division of adult corrections. Helping defendants and protecting the community are duties of both judges and corrections officials, the judge wrote in his sentencing order.

Prosecutor Susan Weller said one of the considerations in allowing Huettel to plead to the lesser charge was that it would make it unnecessary for the boy to testify.

A similar charge against Huettel is pending in Johnson County District Court.

Sex abuse charge filed

4-24-81

[redacted], of [redacted], has been accused of performing a sexual act on the body of an 11-year-old boy on two occasions.

The accusation is contained in a complaint filed by the [redacted] attorney in [redacted] District Court, charging [redacted] with two counts of third-degree sexual abuse in incidents on Dec. 7 or 8, 1979, and March 14 or 15, 1980.

[redacted] was arrested by sheriff's deputies Thursday afternoon and appeared before [redacted]

[redacted] on the charges this morning. The judge set May 4 at 4 p.m. as the time for a preliminary hearing and set bond at \$5,000 on each count. [redacted] returned to the county jail in lieu of bond.

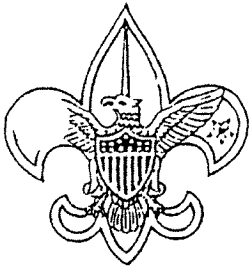
