



# C.R. man receives 5-year sentence on reduced charge

Cedar Rapids The 41-year-old Cedar Rapids man had been charged with two counts of third-degree sexual abuse, which carries a 10-year sentence. He pleaded guilty to a

charge of lascivious acts with a child, which carries the five-year sentence.

Judge Jesperately needs" psychiatric or psychological counseling and that it is necessary for him to be confined for the protection of the community.

The judge said both the objectives he talked about, counseling and protection, would be best served by having placed in a state facility at Mount Pleasant.

The place where the sentence is served is determined by the director of the division of adult corrections. Helping defendants and protecting the community are duties of both judges and corrections officials, the judge wrote in his sentencing order.

Prosecutor Susan Weller said one of the considerations in allowing Huettel to plead to the lesser charge was that it would make lit unnecessary for the boy to testify.

A similar charge against Huettel is pending in Johnson County District Court.


