Principal Won't Face Sex Charges

Criminal charges of sexual abuse on children against a former Irasburg Elementary School Principal cannot be brought because the alleged incidents occurred more than four years ago, Orleans County State's Attorney Philip H. White said Wednesday.

James Riccio, who is under investigation by the state's attorney's office for reports of alleged misconduct, resigned from his job in September.

White said the statute of limitations—the time period in which of charges can be filed—in this case is July 1, 1982. The statute for most crimes is three years. The Legislature increased the limit on sexual abuse this year to six years, but provided for a gradual increase.

The report by Investigator Donald R. Stubbs showed two former. Students indicated that Riccio engaged in inappropriate sexual conduct with them, White said. The alleged incidents occurred on school property while the students were in seventh grade, White said.

Stubbs has been asked to continue his investigation of children who may have had more recent contact with fliccio, who has been a Scout leader for several years, White said.

"I am also asking any parents of children who have knowledge or suspicions regarding inappropriate belivation between Mr. Riccio and their children to please contact my office and talk with Don Stubbs," said white in a prepared statement.

Riccio, reached at his Barton home, said he had not been notified of the results of the investigation into the initial complaint against him. He declined to comment on the investigation.


Riccio's resignation letter, which was accepted by the board a month lago, said he wanted a "career change."


