Please note that the following action has been taken. The supporting documents are attached.

- 1. Mark A. Rieb, Scoutmaster of Troop 16, Sterling, Colorado, was removed December 1, 1988 after an allegation that he initiated and played strip poker with the Scouts on campouts. Mr. Rieb was the only adult present. This action was reported by me to the Department of Social Services in Sterling, Colorado on December 1, 1988. Their report back to me on December 19, 1988 confirmed this allegation. They also are pursuing allegations of sexual abuse. Two Scouts are to undergo counseling.
- 2. The American Legion Post has refused to accept the Council's decision that Mr. Rieb has been removed from Scouting. They have allowed Mr. Rieb to continue meeting with the Scouts.

As a result of the American Legion Post's action, the Council Executive Committee voted to withdraw their charter and has notified the Post of this action.

Suspended or denied registration for following reasons:

Colorado, reported that the troop's Scoutmaster, Mark Rieb, played strip poker with the five to six Scouts on a campout. Mr. Rieb was the only adult present. Mr. Rieb told the boys not to tell anyone of this game.

As Scout Executive, I reported this to the Colorado Department of Social Services. As a result, the case worker, Lisa Sanders, reported to me on December 19, 1988 the following:

- Mark A. Rieb initiated the game of strip poker with his own cards on several occasions. Mark would be the first to lose his clothes. Mark was the only adult present.
- 2. Mark also slept in a tent with a boy on a campout.
- 3. After Mark's membership with the Boy Scouts of America was terminated, he continued to meet with Scouts at troop meetings and also planned a troop campout.
- 4. Mark reportedly has told the Scouts not to tell anyone about what happened on campouts, or he could lose his job.
