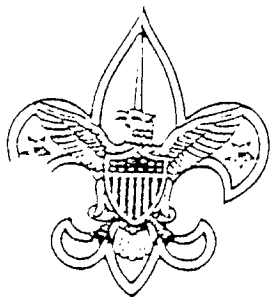



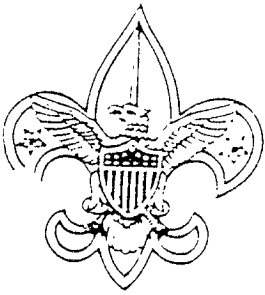

Dear Paul,

This information was recently given to me regarding James Martin Rise, a volunteer currently registered with the BSA as a mate in Ship 724.

In reviewing the material, it looks like there are three issues for your review. First, he must have been convicted of fraud by impersonation in 1956. Second, in July of 1979, he was accused of rape in the third degree. A dismissal order was issued on September 13, 1979. Third, he was charged with sexual abuse in the first degree in 1980; a dismissal order was filed in December, 1980.

Your guidance, please. It is obvious he has not been convicted of the two sexual related charges for reasons indicated. It does seem that we should take some action, however. He has been on the fringe of the program and drifted from place to place in his volunteer roles. We would be prone to deny registration but do seek your guidance.


