We really need more documentation related to the reason Mr. Rollins is being placed on our ineligible volunteer file. We need statements from parents or the youth members, or a narrative from the scoutmaster or other people who were knowledgeable.

We would also like to have information if Mr. Rollins has been arrested by this time. Newspaper clippings or court records would be most helpful. At the present time, we have nothing that would substantiate our refusal, and so, therefore, we need that information.

Thanks for your help in building a better file, so that we are able to refuse registration anywhere in the country.

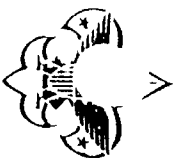

Dear Mr. Rollins:

After careful review, we have decided that your registration with the Boy Scout of America should be suspended. We are therefore compelled to request that you sever any relations you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserved the right to refuse registration whenever there is a concern that an individual may not measure up to the high standards of membership that BSA seeks to provide for American Youth.

If you wish to have this decision reviewed, please write to me within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted or reinstated. The procedures for review are attached.
