Dear Ray:

You indicated to us in December that the above named individual had been removed from registration a couple of years earlier because of some of his actions. We really need more information concerning these actions if we are to place him on the confidential file and refuse registration in another area.

I sent you a Confidential Record Sheet with my letter of December 28 asking that it be completed with as much information as is available. A copy of an application with a signature would help to aid in the identification process.

We would like to have a complete description of the action by someone in the unit or by the Bishop. The broad statement you made leaves many questions about what actually took place.

Please let us know if we can help you in any way to complete this file. We will be glad to contact any other councils if it is indicated that Mr. Sells may have moved to another area.

Dear Ray:

Thank you for your note concerning the suspected child abuse case related to the above individual. I agree with you that he should be removed from Scouting and not allowed to register in the future if there is any evidence at all that this contact took place.

We would really like a signed statement from a parent or from the bishop, indicating what actually transpired. This would be most helpful in documenting and in substantiating this situation.

We would also like a Confidential Record Sheet completed with as much information as is available. We realize that there would not be a lot of the information available since he has left the area, but certainly someone could remember some information concerning his size, weight, color of eyes, or other information which would aid in the identification process. If he was registered, perhaps there is something in your files which would give some of this information since the history file should contain information related to him at the time of registration.

Please do not hesitate to contact me if you have any questions concerning this. We are enclosing a Confidential Record Sheet for your use. Let us know if we may be of help in any other way.

SUBJECT: CHILD SEXUAL ABUSE REPORT

While making a sponsor head visit with Bp. Carl J. Sheperd, [REDACTED] Woodruff, Az 85942 - [REDACTED], Bishop of the Woodruff Ward, LDS Church, which sponsors Pack, Troop, Team and Post 64, a discussion was held concerning the problem of child sexual abuse. Bp. Sheperd indicated that a situation had arisen with one of their leaders about two years earlier in which this man was holding and rubbing the young Cub Scouts. He was removed from the position immediatly and then^{ly} left the area. I explained to Bp. Sheperd that this information needed to be passed on to the National office and entered into the commputer in case he attempted to regsiter in another area. Bp. Sheperd then gave me the name of the individual and what information he had on him.

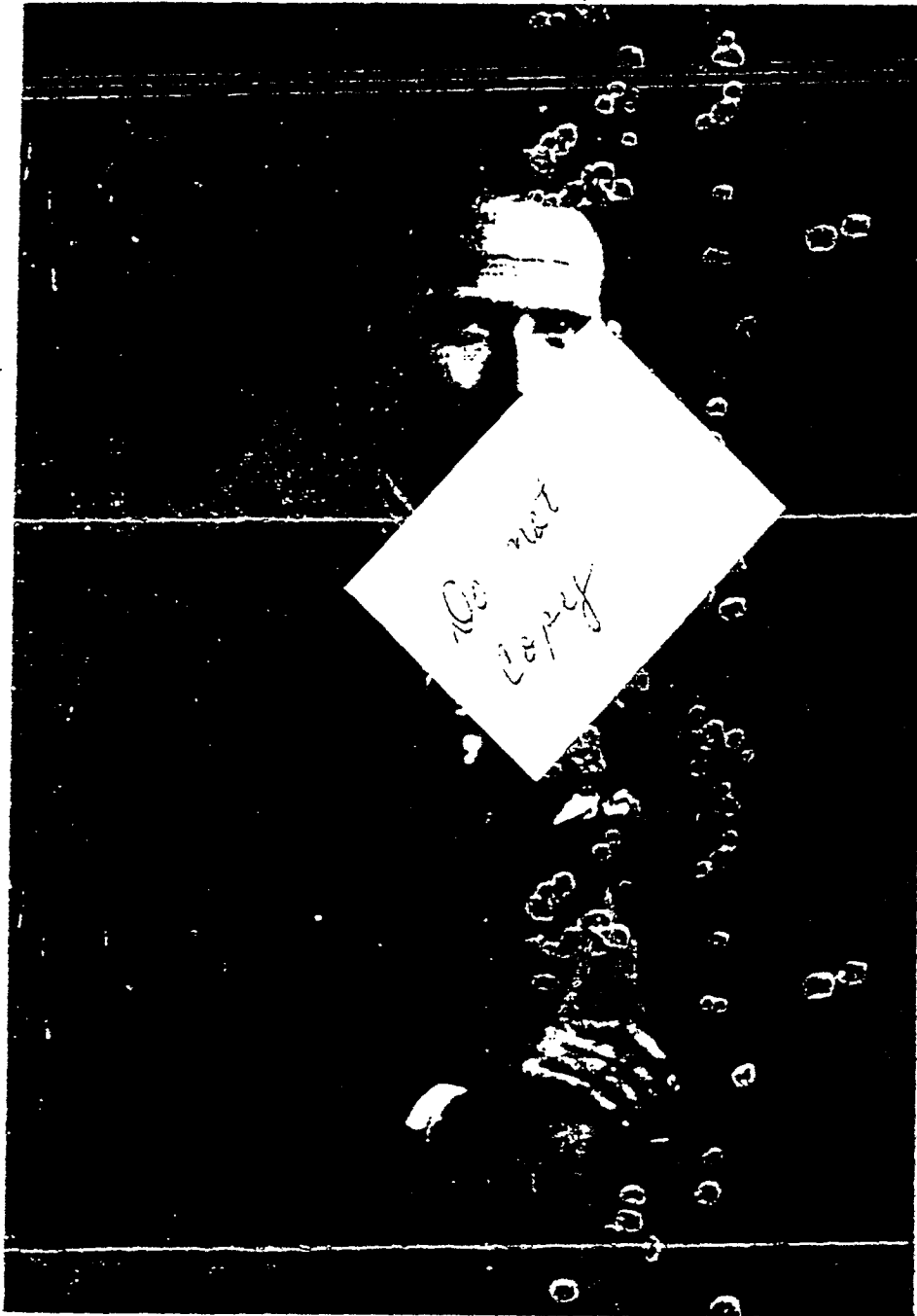
