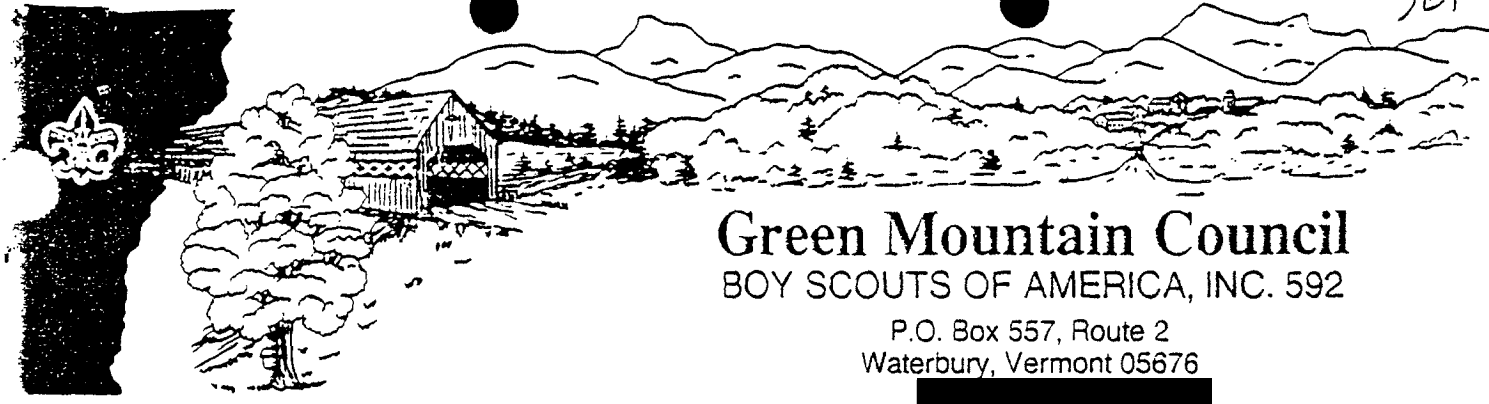

The Shelburne, Vermont police called and gave us information on a Warren E. Steadman Jr. who was a member of committee in Troop 822 in So Hero in the early '70s. He was later registered as a Scoutmaster of Troop 607 in Shelburne in the late '70s and early '80s. He was still residing at the So. Hero address when registered with the Shelburne Troop. He is no longer registered, and according to our records has not been since December, 1980. I am enclosing a copy of the registration form which he completed in 1970.

However, the police said he was related to a sexual child abuse case and just wanted to keep us informed. I am passing this on for what it is worth. We have been unable to obtain any other information on him and his name came up as a result of another case the police are investigating. Use this as you see fit.
