TO THE SHERIFF OF LANCASTER COUNTY, NEBRASKA:

On March 19, 1985, said defendant was duly arraigned and entered a plea of No Contest to the charge Attempted 1st Degree Sexual Assault on a Child (FIII)

On May 17, 1985, said defendant was sentenced by the Hon. William D. Blue as follows:

"It is therefore considered, ordered and adjudged by the Court that said defendant is guilty as charged in The Amended information filed herein,

Defendant appeared with counsel, W. Scott. Deputy County Attorney Hoppe present. Defendant gives no reason why sentence should not be passed against him. The Court finds that defendant is not a mentally disordered sexual offender under the statutes of the State of Nebraska. The defendant is sentenced to a term of (1) one year in an institution under the jurisdiction of the Department of Correctional Services and ordered to pay costs. Credit for 3 days spent in custody. Suspended until May 20, 1985 8:00 a.m.

YOU ARE THEREFORE ORDERED TO EXECUTE THE SENTENCE AND ORDER OF THE COURT.
