The procedures for a review of this decision are attached.

APPLICANT PROCEDURE FOR REQUESTING REVIEW OF DECISION DENYING REGISTRATION

- 1. If registration is refused, the applicant may request a review of this decision. This request must be in the form of a written request from the individual which includes his or her version of the facts supporting the claim that registration should not have been denied.
- 2. Upon receipt of the written request for review, the president of the local council shall appoint a committee to review the situation.
- 3. The appointed committee should review the facts as presented, and, in addition, may interview any persons whose testimony might assist the committee in discovering the truth and arriving at a correct decision.
- 4. A confidential report will be given to the applicant setting forth the decision of the committee.
- 5. The applicant may--if he or she does not agree with the decision--request a review from the regional director by submitting a written request for such a review within 30 days of the receipt of the local council decision.
- 6. If the regional review does not satisfy the applicant, he or she may ask for further review by the National Council by submitting a written request for such a review within 30 days of the receipt of the regional decision. The decision by the National Council is final.

MEMORANDUM OF RECONA April 5, 1988 (Reference Mr. Rick Strobel, SM T591, Phelps, WI)

Received a call from Mr. Wally McGill, Area Director, Area I, E.C. Region, BSA, at approximately 9 PM on April 3, 1988.

Wally reported he had received information from Mr. Jeff Huttenberg, Samoset Council Vice President, that Mr. Rick Strobel has a felony conviction for 2nd degree sexual assault in 1987.

Wally stated he would call the council office and have a letter prepared for the council president's signature, suspending the BSA registration of subject. Wally further stated I should meet with Mr. Ray Ohlsen on Monday, April 4 and accompany him for the delivery of the letter to Mr. Strobel.

I met Mr. Ray Ohlsen, Samoset Council President, in Rhinelander at 2:00 PM. We then proceeded to Phelps and attempted to deliver the letter of suspension. We were unable to contact Mr. Strobel and his wife had no idea where he was or when he would return. While in Phelps, Ray and I contacted Mr. Thomas Wysocki, Committee Chairman for Troop 591. We shared with him our intent and the fact we were unable to make contact with Mr. Strobel.

Ray and I departed Phelps at approximately 4:15 PM.

On return I called Mr. Wally McGill and told him we were unable to contact Mr. Strobel. At this time Wally approved having Headwaters District Commissioner, Mr. John Modjewski, accompany me on our next attempt to deliver the letter.

Met Mr. John Modjewski at his house in Eagle River at approximately 4:30 PM, April 5, 1988. Mr. Strobel was at John's house when I arrived.

In the presence of Mr. John Modjewski I handed the letter to Mr. Strobel and asked him to read it. After Mr. Strobel had read the letter I asked him if he had any questions concerning the letter. He replied "No" and stated "if that's what they want" at which time he got into his car and departed.

At approximately 5:30 PM I called Mr. Wally McGill and reported the delivery of the letter to Mr. Strobel. At approximately 6:30 PM I informed Mr. Thomas Wysocki, Committee Chairman of Troop 591, that Mr. Strobel had received the letter of suspension from registration with BSA and encourged him to convene a committee meeting to begin the selection process for a new Scoutmaster for Troop 591.
