MEMO: Delivery of Letter of Registration Suspension to Anthony Watson

April 6, 1988-4:00PM

I met with Anthony Watson at the Council Service Center. Paul Schilling, Council President was also present.

Tony was given the letter notifying him that his membership registration with the Boy Scouts of America was suspended as of this date.

After he read the letter he stated that we had no other choice. He apologized for his actions. He stated that eight years of work with youth was ended because of a few minutes of not thinking. He stated that he was proud of his boys and that he had been successful keeping them off drugs and alcohol; that they did not smoke and that all but one had a girl friend.

He stated that the irony is that he was instrumental sometime earlier than this incident to have the boy removed from an abusive home and placed in a foster home, he repeatedly expressed his sorrow for what happened. He indicated he had no feelings against Scouting. That we were doing what we must do.

He wishes not to have a trial and stated he must pay for his own actions. He stated he would not hide behind an attorney.

I informed Tony that we will inform the Elks Lodge that they will need to secure a new leader. He thanked me for taking care of that.

Paul and I wished him the best and he left.


