Dear Sir:

This letter is my second correspondence to you concerning my formal request for a review of the decision by the Baltimore Area Council to deny my membership in the Boy Scouts of America. Since repeated telephonic attempts to discuss this matter with either yourself or David Park have met with negative results, this second correspondence is necessary.

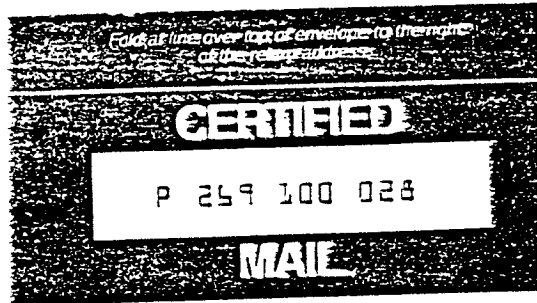
This letter has two parts. The first part will restate my position from the first letter. The second part concerns the information I have been trying to give you telephonically. This additional information is relevant to the allegations made in the first letter. I will be referring to the following BSA Resources:

- 1) The two hour video on the Youth Protection Program, hereafter referred to as the "YPP Video".
- 2) The pamphlet "Youth Protection Guidelines for Explorer Leaders", hereafter referred to as "YPP Explorer Pamphlet".
- 3) The 1989 edition of the pamphlet "Child Sexual Abuse: How to deal with it", also annotated "for professional staff use only" and hereafter referred to as "CSA 34-199".

PART ONE

What we are discussing is a relationship between consenting adults that occurred outside of any Scouting environment and is not the concern of the Boy Scouts of America. Ignoring this legality and despite the age distinction proclaimer at the beginning of the "YPP Video", it has become apparent that this woman was interviewed, processed, and treated as an "abused child" within the framework of BSA's supporting documentation and procedures.

PART TWO

On Monday, August 14, 1989, I was asked to resign from Scouting. The three men in that room with me are Charles I. Lanham, Scout Executive for the Baltimore Area Council; Richard Keefer, Legal Counsel for the Baltimore Area Council; and Bruce Ch. Johnson, Skipper of Ship 561 and member of the National Sea Exploring Committee. On that occasion, Mr. Lanham told me that the only other person knowledgeable of the allegations was Bruce C. "Tripp" McMillan III, Field Operations Director for the Baltimore Area Council, who was on vacation at that time. These four men and their actions will be the subject of the remainder of this letter.

In my previous letter, I detailed the situation concerning my son's abandonment and subsequent verbal abuse at the National Jamboree, Fort A. P. Hill, Virginia. At that time, I was quite vocal to anyone in the Scouting community about my feelings in this matter. After threatening legal action if corrective action was not taken, I was asked to leave Scouting. I have since been able to document the following items for your consideration:

- 1) On Friday, August 4, Mr. McMillan is advised of the potential legal situation and promises to look into it.
- 2) While working at the Jamboree, District Executive Edward T. Kreiner performs the investigation taking statements from knowledgeable individuals and photocopying all relevant documents.
- 3) Between Wednesday, August 9 and Saturday, August 12, the complete investigation is presented to both Mr. Lanham and Mr. McMillan.
- 4) On Monday, August 14, the night of my roundtable and my first opportunity for a vocal forum with a large number of my Scouting peers, I am invited downtown and asked to resign from Scouting immediately ending all my Scouting activities except the slow withdrawal from Troop 889 where I am Scoutmaster.
- 5) On Monday, September 11, after being put so significantly on the defensive, I am told by Mr. McMillan concerning the matter of my son:
 - a) Mr. Kreiner left Scouting without giving any report.
 - b) With Jamboree participants disbursed nationwide, it is not reasonable to pursue any type of investigation.
 - c) I should drop the issue and get on with my life.

- 6) By a verbal agreement from the August 14 meeting, I should be completely out of Scouting by September's end. During the first weekend of October, I attend my District's Camporee as Scoutmaster of Troop 889 with my wife as the other adult present for the weekend. No other unit adults were available. The troop's only active Assistant Scoutmaster was attending Woodbadge and the man who was to replace me as Scoutmaster had declined.
- 7) On October 20, I attend a private Woodbadge ceremony at a friend's home with my wife. Scouters who should not be knowledgeable of this situation are upset that I'm there.
- 8) On October 25, while transporting [REDACTED] carpool to a Ship 361 meeting, I discover the woman is still active.
- 9) On November 2, I am presented with the material found in Appendix C of "CSA 34-199".
- 10) In December, I appeal Baltimore's decision to the Region.
- 11) In March, the Region supports Baltimore's decision.
- 12) On March 19, I discover the existence of the complete investigation concerning [REDACTED] incident.
- 13) Since April 9, my request for a National Review of this situation has been in the National Office.

Later I will discuss in greater detail the November 2nd meeting and the activities that have become known to me concerning the October Camporee. At this point, a strong argument can be made for the following two important issues:

- 1) I was not denied membership over my relationship with the woman, but that your policy was abused to discredit me and my allegations concerning [REDACTED]
- 2) The guidelines for two major BSA policies have been used to manufacture a case of child sexual abuse to discredit one Scouter and cover documentable issues of verbal abuse and child abandonment involving as many as seven adult Scouters from two countries participating in Council sponsored programs under International Scouting Guidelines.

On November 2, 1989, my lawyer and I attended a meeting with Mr. Lanham, Mr. Keefer, and another lawyer from Mr. Keefer's firm. We were concerned for two major issues at this meeting. First I was concerned that this was being treated as a child sexual abuse situation although no one at the August meeting had stated same. The second major topic of this meeting concerned confidentiality. Mr. Lanham opened the meeting by presenting me with the letter

denying my membership exactly as detailed in Appendix C of "CSA: 34-199". Since no one at the August meeting had mentioned Sexual Abuse, I presumed erroneously that both the woman and myself were being asked to leave Scouting to prevent a potentially embarrassing situation. On October 25th, when I discovered the woman was still active in her unit, I realized that this was being treated as a child abuse situation. This was confirmed when Mr. Keefer opened my file in his conference room and began quoting directly from "CSA 34-199". When Mr. Keefer was pressured to explain how this situation differed from any other extra-marital affair between consenting adults, he stated that it was not the Council's initial reaction to deny membership, but they had followed the insistence of my friend, Mr. Johnson. As I mentioned in the last letter, Mr. Johnson was responsible for [REDACTED] at the National Sea Exploring Exhibit at the Jamboree when a Scouter removed him from that exhibit and began the verbal abuse. After reviewing the guidelines from both the "WPG Explorer Pamphlet" and "WPP Video", a strong argument can be made for the fact that in this instance, considering the broad range of my Scouting contributions, a denial of membership was excessive when my quiet removal from the unit where the woman was a member would have accomplished the same result. This one issue of a clearly excessive implementation of a denial had not made any sense from the very beginning. This issue has allowed me to look to other reasons, and the book I am building is neither pretty nor what I had learned to love about Scouting.

At this meeting, I expressed concern that despite assurances of confidentiality given to me by Mr. Lanham in the August meeting, it was becoming apparent that information concerning this matter had been leaked to my peers in the district where I had been a very active and key volunteer for over five years. At that point in time, I had no information concerning the source or content of the leaked information. Mr. Lanham assured me that no one employed by the Baltimore Area Council had released or made public anything discussed in the August meeting. Mr. Lanham reconfirmed that the only individuals knowledgeable of the allegations were Mr. McMillan, Mr. Keefer, Mr. Johnson, and himself. Mr. Keefer, who also is a volunteer with a unit in my district, mentioned that he had heard people in the District were discussing this and implied that my lawyer could take action against any volunteer we could identify as the source of the leaked information, but no employee of the Baltimore Area Council had violated confidentiality.

After leaving that office, my lawyer and I discussed how this did not make sense or even seem reasonable from a legal point of view. Following my lawyer's advise, I immediately withdrew from all Scouting activities to use the BSA's administrative appeal process. Within one week, Mr. Keefer sent my lawyer a letter confirming that volunteers in the District had been knowledgeable of the allegations prior to the November 2nd meeting, but he did not indicate the source of their information. His letter further accused me of participation as a uniformed Scouter in a Council Orienteering event on November 4th and threatened an injunction unless I stopped all Scouting activities except those that any unregistered parent are allowed to enjoy. An unnamed professional reported seeing me at that event. I have statements from District volunteers confirming my absence from that event. This is not an easy mistake to make as I am over six feet tall, weigh well over 200 pounds, and am the only very active male Scouter who needs wrist crutches to get around.

It is important, at this point, to review the sentence that begins on line 6, page 11, of "CSA 34-199", which states "All allegations should be kept strictly confidential, with as few people involved and as little discussion about the matter as possible." The information was leaked during the District Camporee that occurred on the first weekend of October 1989. I have attended this event for the past six years. In 1989, I attended as Scoutmaster of Troop 889, camping that weekend with my wife, who was the second adult in our campsite. Bearing in mind that I have only been accused of having a consensual heterosexual relationship with a woman of legal age outside of Scouting, and attended the Camporee with boys from my Troop, the next revelation will seem to be almost insidious in its maliciousness and damning results.


We have statements from district volunteers who were recruited by a Professional employee of the Baltimore Area Council to "keep an eye on me" for the entire weekend of the Camporee. My friends and peers were convinced to overlook their five years of trust in me by the serious nature of the following four allegations and the supposedly righteous and unimpeachable source of their information:

- 1) I was not supposed to be there that weekend.
- 2) I had been kicked out of Scouting.
- 3) I had an illicit affair with a female Explorer.
- 4) I had raped the woman in question.

The Professional employee responsible for these statements is Mr. Bruce C. "Tripp" McMillan III, Field Operations Director for the Baltimore Area Council. There is no excuse for this conduct. Stating the obvious, a Professional, who should know better, has publicly accused me of a capital crime.

Thus ends the information I have been attempting to give you over the telephone for the past four weeks. I love Scouting very much; and it saddens me to be in such a strong legal position on these two matters. Please do not leave me with the public forum as my only way to right this wrong and prevent similar situations from damaging others.

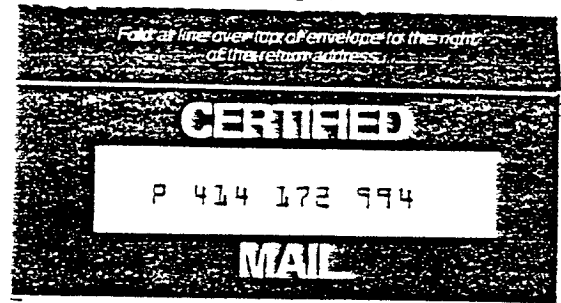

Dear Sir:

It is probable that programs of the Boy Scouts of America have been misused in a gross miscarriage of justice. I've been had; and I'm mad as hell about these developments. Please accept this as a formal request for a review of the decision by the Baltimore Area Council to deny my membership in the Boy Scouts of America.

I have spent the last 8 months agonizing over, and trying to understand, the decision by the Baltimore Area Council to deny my membership. Since August 14, 1989, I have maintained continually that any relationship between consenting adults that occurs outside of scouting is not the concern of the BSA. This legality so conveniently ignored has confused myself, my lawyer, and the friends I worked with in Scouting who have become knowledgeable of this situation. The assured confidentiality of the Youth Protection Program has been used to keep statements and accusations necessary for a reasonable defense from being given to me. Both veiled and direct references to an arbitrary and capricious "standard of membership" have held me accountable in my private life to a performance standard with secret guidelines. These programs have been used to keep me in confusion until the following facts were minimized and forgotten.

After Charlie Ball sent me the attached letter of March 12, wherein the Northeast Region Review Committee upheld the initial denial by the Baltimore Area Council, I almost dropped the issue entirely. In the last month, three people have provided me with information that is relevant and casts a new light on this situation. The dates of the following time frame of events is critical and inexcuseable in their obvious conclusions.

For the past 5 years, the Baltimore Area Council has participated in a joint Scout exchange program with the Boy Scouts from Baltimore's sister city of Kawasaki, Japan. Last year, [REDACTED] participated in the program which included attendance at the opening program and following day activities at the National Jamboree at Fort A. P. Hill. Through a disastrous chain of negligent events, [REDACTED] was abandoned overnight at the Jamboree for over 12 hours by the adults responsible for this venture. [REDACTED] was to work at the Sea Exploring Exhibit the following day. When a Scouter affiliated with the contingent "found" him at the exhibit, therein began what was to become over 18 hours of verbal abuse by those Scouters in the contingent. [REDACTED] was returned home in tears. The exchange Japanese Scout was removed from my home. [REDACTED] was excluded from the last two days activities with the contingent. The 12 hours of neglect and abandonment can be confirmed through the official Military Police Logs, Fort A. P. Hill, something I was able to accomplish with one telephone call.

On Friday, August 4, 1989, I told Tripp McMillan, Field Operations Director for the Baltimore Area Council, what had happened and that I was extremely upset. I was perhaps foolish enough to threaten legal action unless [REDACTED] received an apology and the responsible adults were effectively reprimanded. He assured me that he would have someone look into this situation while the Jamboree was still in progress.

On Monday, August 14, 1989, ten days later, I was asked to leave Scouting because of an affair I had with a female explorer. It was apparent then and confirmed at the regional review committee that this woman was interviewed as an abused child! The fact that this relationship involved consenting adults away from scouting seemed to concern noone in the room.

On Monday, September 11, 1989, at Roundtable, I asked Tripp McMillan the status of his investigation into the situation involving [REDACTED]. I was told that the professional he had asked to look into it had left Scouting without providing him with any definitive information and because of the lapse in time since the close of the Jamboree it would not be reasonable to reinvestigate. I was advised to let the situation drop since they could now do nothing about it.

On Monday, March 19, 1990, I discovered that a complete and detailed investigation of the incident concerning [REDACTED] exists. This collection of documents includes statements from knowledgeable persons interviewed at the Jamboree and photocopies of all relevant records. The original investigation was presented to Charles Lanham, Scout Executive for the Baltimore Area Council. A complete copy of the investigation was presented to Tripp McMillan. Both Tripp McMillan and Charles Lanham discussed the investigation with the professional who conducted same prior to the August 14th meeting mentioned above.

After a lengthy consultation with my lawyer on Tuesday, March 20, 1990, my only regret is that the legal recourse available to me is civil and not criminal. It is a shame that the Youth Protection Program guidelines have been used to "manufacture" a case of child sexual abuse involving one Scouter to cover "actual" cases of verbal abuse and child abandonment involving as many as 7 adult Scouters from two countries participating in council sponsored programs under International Scouting Guidelines.

I mentioned earlier in this letter that three people have come to me with information. You may want to have an investigator from outside this area reinterview the woman in question. Upon advise of my lawyer, I have not had any contact with her since last June. It has come to my attention that she may have been caught in a lie and had to legitimize that lie in her statement in order to stay in Exploring. You may find that she was specifically coached to exclude damaging information concerning her behavior as an Explorer that might be considered injurious to others. The woman's statement was never read to me. The legal counsel in attendance at the August 14 meeting read excerpts concerning graphic visual imagery of sex acts to which I admitted to stop the shock of his prying exposure of something intensely personal and private. Through others I have learned that the woman expected me to deny the statement as she presented it, but it was not presented to me the way she anticipated.

The August 14 meeting was also attended by C. Bruce Johnson, Skipper of Ship 361 and member of the National Sea Exploring Committee. I presumed he was present out of concern for a member of his unit and had no personal interest in the outcome. I may be wrong when you

consider that [REDACTED] was working for this man at the National Sea Exploring Exhibit when another Scouter was able to "remove" him from the exhibit area precipitating the 18 hours of verbal abuse.

I realize that this is the last review in the BSA Administrative review process. I am aware that these reviews are non-judicial; but unless you can give me a very good reason why not, I would, at this point, prefer to have lawyers involved.

This afternoon at 2:30 p.m. Mr. Taunton Welsh and his attorney Mr. James G. Maggio, whose address is [REDACTED], telephone [REDACTED], Towson, Maryland 21204, Charles Lanham, Scout Executive, Ira K. Himmel, and I met in our conference room with respect to revoking the registration of Mr. Welsh. By way of background, at a meeting on August 14, 1989 attended by C. Lanham, Bruce Johnson, advisor to the Post where the girl is a member, and Taunton Welsh, a volunteer Scouter, the situation was discussed, and Welsh had agreed to withdraw from Scouting by September 30, 1989. Apparently, he did not, and based upon evidence that he had continued in Scouting activities, it was determined to revoke his registration.

The procedure for revoking the registration in a situation involving possible child sexual abuse is set forth in a pamphlet entitled "Child Sexual Abuse", and it provides for a specific mechanism. A letter was prepared word for word in accordance with the letter set out in the pamphlet. Also prepared was a set of instructions for his taking an appeal to the Northeast Region. Today's meeting was called to present this letter to him together with a refund of his registration and the procedures for taking an appeal. The pamphlet requires that these be personally delivered to the person involved by a professional Scouter and a volunteer. The meeting began by my advising Mr. Welsh and his attorney that at the meeting on August 14, 1989 Welsh had agreed to withdraw from Scouting and that we had given him six weeks, that is until September 30th, in which to do so. This gave him an opportunity to withdraw from Scouting in a graceful manner to be determined by him. We also reminded Welsh that he had agreed to keep the whole matter confidential and we would not talk to any one in order to give Welsh complete ability to voluntarily withdraw. There is no question with respect to the factual situation concerning his termination-as-a-member-of-the Boy Scouts of America. At that meeting he readily agreed that a sexual encounter had taken place at different times at his home.

Mr. Maggio stated that Mr. Welsh was quite upset with the situation, that there was considerable talk in his neighborhood, he had lost friends, and he is looked upon as a pedophile. He

stated that there was a Scout meeting at which the lady in question had attended and that he thought the Scout organization had reneged because he was under the impression that she too had been banned from Scouting. We pointed out to them that there was no discussion or agreement that she would also be denied a role in Scouting. Furthermore, her role in Scouting has nothing to do with him. Their position is that his reputation as a pedophile has caused great mental anguish, and has ruined him socially in the neighborhood. He wants to be "exonerated". We emphasized that neither Mr. Lanham nor I have talked to anyone concerning this matter.

We pointed out to Welsh and Maggio that neither he nor anyone else has a right to be a volunteer Scouter and that membership in Scouting is a privilege not a right. We told them that under the circumstances there is no way that Welsh can retain his membership in the Boy Scouts except and unless he takes an appeal to the Regional office and our decision is reversed.

The attorney indicated that they would exhaust the administrative procedures, but if they could not get any satisfaction (whatever that means) by the administrative procedures that they would have to consider taking other action.

At one point Welsh stated that he had been denied the right to purchase items from the Scout store. We have no verification of that, but Mr. Lanham assured him that no such instruction had been told to the store, at least by him. We pointed out that we were making no moral judgment with respect to Welsh's actions, but emphasized that because the sexual encounter had taken place at a Scouting activity; namely, the visiting of his home by the lady in question, who is a member of the Explorer Post in which he is involved, who came on a Scouting activity (presumably to pass a test of some sort), that this represented an activity that could not be condoned by Scouting. We pointed out to him also that the situation could happen again in the future involving someone under the age of eighteen (18), and if such a situation did develop, our Council would be in a vulnerable legal position. (The 2 incidents occurred in November - December, 1988. The young lady had kept it quite and did not want her parents to know. She was involved in the National Jamboree in the summer of 1989 and while there saw the films on preventing sex abuse. This impressed her and caused her to go to Bruce Johnson, the Past Advisor, because she did not want some younger girl to go through a similar experience. This is what triggered the matter because Johnson called Trip McMillan, who told Charles Lanham) The attorney stated that we were "jumping to future conclusions". In any event, we reiterated that the action taken today was final and complete as far as the Council was concerned, but that Mr. Welsh had the full opportunity to take an appeal to the Northeast Region. The entire meeting lasted approximately one-half hour.

As of November 2nd Mr. Welsh had no further right to wear the Scout uniform in public or to participate officially or unofficially as an adult Scouter in any Scout activity. As you probably know, Mr. Welsh has a son who is a member of Explorer Ship 361. Mr. Welsh is free to attend any Scouting activities in which his son is involved and which are open to parents.

Now it has come to Mr. Lanham's attention that on November 4th and 5th, after our meeting of November 2nd, Mr. Welsh took his Boy Scout Troop for a weekend training course in the State Forest Reserve in Howard County, conducted by the National Pike District. In addition, a member of the Baltimore Area Council, who had no knowledge whatsoever concerning the recent developments involving Mr. Welsh, called him to request him to serve as an instructor at an annual training session to be held next March. I advised you in our telephone conversation that there had been no communication by the Scout office with anyone concerning this matter except the several people who comprised a part of the leadership of the National Pike District, the geographical area in which Mr. Welsh carried on his Scouting activities. The people contacted already knew of Mr. Welsh's situation from sources other than Scout headquarters. However, I must now advise you that unless Mr. Welsh ceases to appear in public in his Scout uniform, and unless he refrains from participating officially or unofficially in Scout activities, other than as a parent of a Scout, a formal announcement will be made to all concerned that Mr. Welsh is no longer a registered Scouter and that he is to be denied participation in any Scouting activity. 


