Mr. David Whipple, Route 6, West Bend, Wisconsin, registered as Scoutmaster of Troop 27, sponsored by Our Saviors Lutheran Church, West Bend, Wi., has been removed from leadership. Mr. Whipple's police record shows two counts of prison due to morals.

Please advise as to information and material needed to eliminate his future registration.

Also, Mr. Larry Nummerdor, currently not registered - past registration as Scoutmaster of Troop 11, Waupun, Wis. sponsored by the Knights of Columbus and American Legion, has been removed from leadership by Unit Committee. Mr. Nummerdor has also been accused by parents of mis-action with youth.

Please advise as to the action we should take and information needed by you.
