I have also hiked some of the cities, state forests and many of the state parks. I have bicycled miles and canoed much of the Edisto river,

Some of troop 601's streamers, and accomplishments were, had won. Yes Sir, this has been educational and exciting two years and, all through the eyes of a Boy Scout.

You and your staff have taken great pride in teaching our young men the building blocks of tomorrow, the enjoyment of self accomplishment and the magic of group effort and achievement. Encompassing the heart of Scouting, Assistant Scoutmaster R.J. Kennedy has taken on the broad and varied task of teaching the youngest and newest scouts. In the leadership of both of you has ^{been} troop 601, one of the proudest and most active troops in South Carolina. I am proud that I have had the chance to serve with both of you, and I salute you.

CHRONOLOGY OF EVENTS LEADING
TO THE REQUEST FOR RESIGNATION
OF LLOYD WILLOCK

1. An anonymous call was received in the Scout Service Center at approximately 11:00 p.m. on 8/23/87 by Senior District Executive Robert Scherini.
2. The lady calling stated that a friend of hers told her that Lloyd Willock went on a camping trip the weekend of 8/20 with a group of Scouts.
3. The informant stated that the caller stated that she and her husband knew Lloyd Willock from Fort Jackson Military Base and that he had been arrested for child abuse at one time. She also understood that he was arrested in Lexington County about three years ago on similar charge.
4. The caller stated that she personally knew Lloyd and that he is not the kind of person that should be involved with youth.

Summary

Staff member Robert Scherini stated that the caller seemed very sincere and in his opinion was truthful and he had no reason to doubt the motive of the call.

The above information was submitted to Jim Dalton, Scout Executive, on August 24. Follow up was made with Lexington County Sheriff's Department through Officer Bob Ford. After an effort to identify a criminal record for Lloyd Willock, it was concluded there were no charges contained in Lexington County records. Other follow-up action by Bob Ford with officials at Fort Jackson using information including the birth date of Jan. 2, 1941 revealed that Lloyd Willock had been treated for child sexual abuse in 1984 for an incident involving [REDACTED]. It was concluded that these were [REDACTED]. This was all the information we were able to secure through our initial contact sources at Fort Jackson.

On September 2nd, Jim Dalton called Paul Ernst, Director of Registration and Fulfillment Service. He was advised to request a resignation of Lloyd Willock directly through the Troop Committee and to submit the Confidential Record Sheet to the National Office.

This action has been taken at the time of this initial report. We will keep you informed as needed on the progress of this case in accordance with the Procedures for Maintaining Standards of Leadership.
