But Officer Injured in Dive Atop Fugitive

A Federal prisoner's vain attempt to escape as he was being taken to a courtroom for trial on the Postoffice third floor Tuesday resulted in an ankle injury for a deputy marshal.

Raymond G. Griffin, 33, who is charged with Mann Act violation, made a dash down the stairway at about 9:05 a. m.

Deputy Earl Sweeney, Lincoln, dove after Griffin and fell on top of him at the landing. Mr. Sweeney's ankle was hurt, possibly broken, in the fall.


Dear Sir:

This is to advise that on February 24, 1960, the Federal Grand Jury returned an indictment against the above-named defendant charging him with transporting a certain girl and a certain woman in interstate commerce for the purpose of prostitution and debauchery, in violation of Title 18, United States Code, Section 2421.

The case came on for trial on March 21, 1960. The case was submitted to the jury Tuesday afternoon, March 22, and a verdict of guilty was returned on that date.

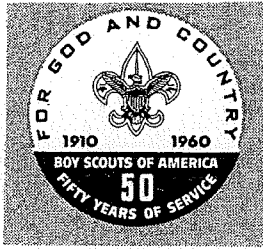

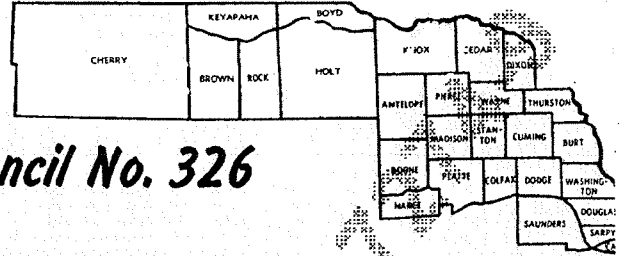
