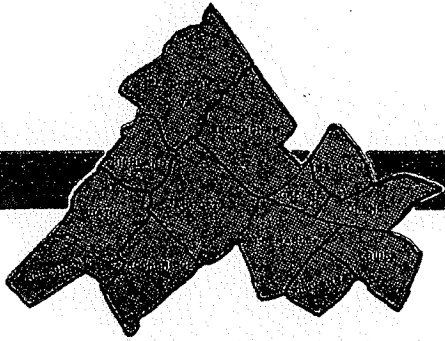


Dear Mr. Boyd:

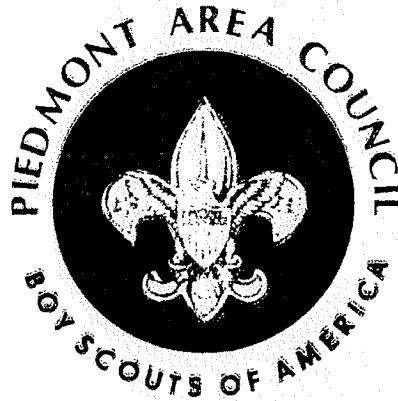

Dear Roy:

The information we have on J. Edgar Haynesworth, III is from the Chief of Police, Otto Overton, Farmville, Va. He secured it from the Staunton Police Department, Lynchburg Police Department and the Richmond Office of the F. B. I. I have two of the original teletype responses to Chief Overton, one from the Staunton Police force and Lynchburg Police Department.

Haynesworth was apprehended in the following counties for reasons of contributing to the delinquency of a minor: Lynchburg, proper; Fluvanna County, Prince Edward County and Augusta County. Warrants are still pending in Lynchburg and he is supposed to be out on bail from Fluvanna. He has an undesirable discharge from the Armed Forces. He was a voluntary mental patient at the State Hospital and discharged as unimproved.

That is all we have. It is too bad we did not have this information here when you asked us for his Scouting record.

We look forward to receiving the additional reports you mention in your letter so that we may have them in our files for future identification and reference purposes.

I am sure you realize that this leaves Troop 84 without any registered unit leader. Undoubtedly, someone is taking over in this position. In order for the unit to continue to receive program inserts in Scouting Magazine, it will be necessary to advise this office of the name of the new unit leader. This should be done by filing with us an additional enrollment for this individual in his new position. Please do not file a separation notice as we have already dropped the current leader.

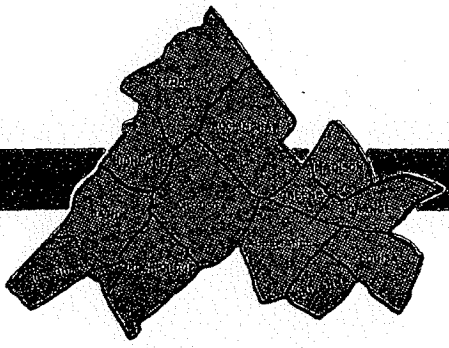

Dear Doctor Wilson:

Information has come to us as of Tuesday morning, November 8, 1966, that Josiah Edgar Haynesworth, III, Route 1, Box 966, Stuarts Draft--registered as Scoutmaster of Troop 84--should be placed in the Confidential File as being unacceptable for Scouting activities. Our original report on him comes from Neighborhood Commissioner, John W. Peery. Then on Wednesday, November 9, 1966, we received a call from Regional Deputy Scout Executive, Harry E. Mangle, from Lynchburg, Virginia, advising us that a warrant for the arrest of the above named had been issued in Lynchburg, Virginia. The charge: Molesting boys.

At the time that Mr. Haynesworth came into participation as Assistant Scoutmaster in Troop 84 on April 6, 1966, we attempted to get some positive information on this young man. However, he was vouched for by the men of the Stuarts Draft area. In September, when he was considered for Scoutmastership, we addressed an inquiry to the Piedmont Area Council at Lynchburg, Virginia, to secure as much information as we could about this young man. All they could advise us was that he had been registered on Troop 11 as Edgar Haynesworth from May, 1949, until October, 1951. He was a Tenderfoot Scout and lived at 1621 Link Road, Lynchburg. No further verification of his past Scouting record could be obtained, although he told me personally that he originally joined Troop 11 of Lynchburg and then Troop 7 and Post 2011. He also stated that he had been registered as a volunteer adult leader in Troop 11 of Lynchburg. He had not attended Council Camp. Lynchburg was not able to give us any character evaluation since none of the present administration knew this young man.

As of this morning we are now able to give you the following information subject to correction and verification:

Josiah Edgar Haynesworth, III

From time to time known as "Ed" or "Tex"

Age of date: 29

Height: 6'6" +

He has stated that he is 7 feet tall

We would grade him as medium build

Dark hair

He is unmarried

He has been living until the last few days at the home of the Institutional Representative of Troop 84 of Stuarts Draft, Mr. Harry H. Wilson. We understand that his father is a medical doctor in Lynchburg and probably has been active in Scouting. At one time we understand that he worked for the Stuarts Draft Milling Company and more recently for Virginia Metalcrafters of Waynesboro. This morning we learned that he is a former patient at Western State (mental hospital) at Staunton.

Of course, had we been able to secure this information previously, we would not have recommended him for commission in the Boy Scouts of America. (The molesting incident took place in Lynchburg, Virginia.)

I am expecting to get a report from the Council Office at Lynchburg (Paul E. Crossan, Jr., Scout Executive) and a report from Mr. Jack Black, former Scoutmaster of Troop 84 and a prominent citizen of this community. These will be sent to you as soon as received.

In the meantime, please place this man on the Confidential File to be barred from any further participation in Scouting. We have advised the Registration Service to cancel his membership. A copy of the Separation Notice is enclosed.
