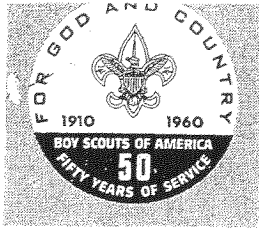

SUBJECT: Separation Notices Returned

A boy or adult can only be separated prior to the expiration of his unit for the following reasons:

1. When a boy or an adult is transferred from one unit to another.
2. When an adult changes position within a unit or a council.
3. When a Scout or Explorer reaches 18 years of age, and is registered as an Assistant Scoutmaster or Associate Advisor.
4. When a member dies.

When a boy or adult pays a registration fee, he is entitled to membership until the expiration date indicated on the membership certificate.

Many times in moving from one state to another, or one community to another, a boy may not find a unit organized in his new community. Since his membership in the national organization is valid until his card expires, he should not be separated. The National office will automatically drop him when the unit expires.

We are, therefore, returning the attached separation notices to your council for the reasons checked below:

1.  SEPARATED FOR REASONS OTHER THAN TRANSFER, DEATH, OR PROMOTION. These boys or adults should be reinstated on your records.

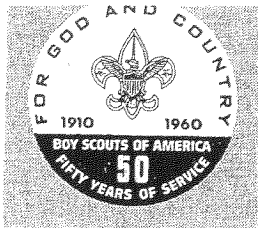

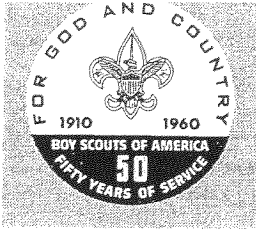

Dear Skipper:

Please place the name of Benjamin C. Forsterling, Scoutmaster of Troop 24, Elkhart Lake, Wisconsin, in our confidential file at once.

The Sheboygan County Sheriff's Department has found him guilty of having abnormal relations with a number of boys.

This has been substantiated by a lie detector test which Mr. Forsterling underwent in Madison, Wisconsin, by detailed statements from several boys and by a psychiatrist who is treating him.

The ironic part of it is that he has established a record as instructor for the American Red Cross for many years, has served as Chief of Police of Elkhart Lake, Wisconsin and has been in Scouting since April 1931.

In order for you to have a complete file on him, we have summarized his record in Scouting which is as follows:
