

His Driver's License expires 2/16/70, he had one (1) warning letter written in Oregon, Illinois on 9/28/68 and at that time he had Illinois Registration AJ6638. The warning letter was for a tail light violation.

It was learned that the suspect had attended a college in Milwaukee, Wisconsin and an electronic achool. A teletype message was sent to the Wisconsin State Police. They advised no record or wanted their files on DALE D. VELINE.

On Movember 19, 1969 Reporting Detectives interviewed was interviewed in the presence of Rockford, Illinois. werbally admitted numerous sexual contacts with the suspect stating that all of them were mesturbation deals where he would masturbate the suspect and the suspect would masturbate him, these occurred at campouts.

Reporting Detectives interviewed JIM TALKINGTOM, 1219 20th Street, Rockford, Illinois. Jik was interviewed in the presence of his father. He denied any sexual contact with the suspect.

On Movember 20, 1969 Reporting Detectives went to the Winnebago County States Attorney's Office where a complaint was signed by Detective I warrant was issued for DALE D. VELINE arrest. Detective and Treoper George Freden arrested DALE VELINE at his home and advised him of his rights, at which time DALE VELIME gave a three (3) page signed statement admitting sexual relations with three (3) different boys of the Scout Troop covering a period from 1966 to the present time. (Statement attached).

After giving the statement, and personal history the suspect was taken to the Winnebago County Jail and the suspect was held in lieu of thirty-five hundred dollar (\$3,500.00) bond. He later poeted bond and VELINE released; no trial date has been set.

Reporting Detectives contected Mr. Miller, Executive Director of the Boy Scouts in Rockford, Illinois and informed him of the arrest of the suspect. We were advised that Mr. Miller will advise the Mational Boy Scouts Office and DALE VELIME will be dropped from all scouting work.
