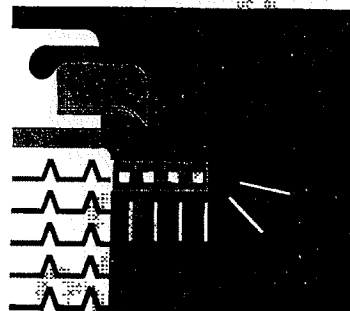

SYNOPSIS:

On September 16, 1969 Detective [REDACTED] received a written request from Reinhold G. Miller, Executive Director of the Boy Scouts located at 1800 7th Avenue, Rockford, Illinois. In the letter Mr. Miller stated that several fathers of boys ranging from age twelve (12) to fourteen (14) had complained to him about one (1) of their scout masters, a DALE VELINE. It was reported that VELINE had been taking indecent liberties with their sons. They wanted him to fire the scout master but he stated he could not without proof which their fathers didn't have and the boys wouldn't admit. Mr. Miller wanted us to interview four (4) boys and determine if there was any truth reference this matter.

Record checks were made at the Rockford Police Department, Winnebago County Sheriff's Office, Loves Park Police Department, Winnebago County State Attorney's Office and the B of I at Joliet - all had no record on DALE VELINE, the suspect. A check of auto registration files, Springfield revealed DALE D. VELINE, same address, his Driver's License #V45016439047, Social Security [REDACTED]. He had Illinois Registration 1969 AG9346 on a 1965 Chevrolet Coupe.

Check at the Driver's License Bureau in Springfield on DALE VELINE revealed date of birth as 2/16/39. He is described as a W/M, 5'9", 140 lbs., blond hair, blue eyes. His Driver's License expires 2/16/70, he had one (1) warning letter written in Oregon, Illinois on 9/28/68 and at that time he had Illinois Registration AJ6638. The warning letter was for a tail light violation.

It was learned that the suspect had attended a college in Milwaukee, Wisconsin and an electronic school. A teletype message was sent to the Wisconsin State Police. They advised no record or wanted their files on DALE D. VELINE.

SYNOPSIS CONT'D:

On November 19, 1969 Reporting Detectives interviewed [REDACTED] of [REDACTED], Rockford, Illinois. [REDACTED] was interviewed in the presence of his parent. [REDACTED] verbally admitted numerous sexual contacts with the suspect stating that all of them were masturbation deals where he would masturbate the suspect and the suspect would masturbate him, these occurred at campouts.

Reporting Detectives interviewed JIM TALKINGTON, 1219 20th Street, Rockford, Illinois. JIM was interviewed in the presence of his father. He denied any sexual contact with the suspect.

[REDACTED] of [REDACTED], Rockford, Illinois was interviewed in the presence of his parents. He admitted working close with the suspect in the electronics field as a ham operator, however, denied any sexual contact with the suspect.

Reporting Detectives interviewed [REDACTED], age 14, in the presence of his mother at [REDACTED], Rockford, Illinois. [REDACTED] gave a signed written statement admitting many sexual acts with the suspect. (Statement attached). "Mrs. [REDACTED] witnessed the statement and stated that she had talked with her husband by telephone stating they would sign a complaint against the suspect.

On November 20, 1969 Reporting Detectives went to the Winnebago County States Attorney's Office where a complaint was signed by Detective [REDACTED]. A warrant was issued for DALE D. VELINE arrest. Detective [REDACTED] and Trooper George Freden arrested DALE VELINE at his home and advised him of his rights, at which time DALE VELINE gave a three (3) page signed statement admitting sexual relations with three (3) different boys of the Scout Troop covering a period from 1966 to the present time. (Statement attached).

After giving the statement and personal history the suspect was taken to the Winnebago County Jail and the suspect was held in lieu of thirty-five hundred dollar (\$3,500.00) bond. He later posted bond and VELINE released; no trial date has been set.

Reporting Detectives contacted Mr. Miller, Executive Director of the Boy Scouts in Rockford, Illinois and informed him of the arrest of the suspect. We were advised that Mr. Miller will advise the National Boy Scouts Office and DALE VELINE will be dropped from all scouting work.

During the first week of Nov. 1969 I went to Dale Valina's house at 2333 14th Ave. in Rockford, Ill. I arrived at approximately 11:10 p.m. At first Dale and I went upstairs and stayed for awhile. Then Dale told me to pull my pants down, which I did. Dale pulled his pants down also, our pants were pulled down to about our knees. I then masturbated and Dale did also. I did not climax, Dale did climax however. We then both pulled our pants back up and read some books. This has happened many times. We have did this approx. 3 times a month for the past two years. That I have known Dale. About half of these times Dale would make me masturbate then and he would do it to me at the same time. Most of these times we would be laying on the bed side by side.

Some where near the end of 1966 I started having relations with [REDACTED]. By relations I mean masturbation. I would masturbate [REDACTED] and he would do the same to me. When it climaxed I would just let it come out, on myself or the floor. I started with [REDACTED] when working on electronics, after a short time I got to liking him a little too much, and we had relations. He didn't force and I never forced him. During this period [REDACTED] and I had relations approx. 2 per week, sometimes twice. These occurred either at my home or while on camping trips. During the last winter or early spring of 1967 I quit having relations with [REDACTED] because he was getting older and had more school activities, and outside activities.

I then took up with [REDACTED] who then lived across from me at 2330 17th Ave. [REDACTED] and I had the same type of sex activities up until August of 1967 when [REDACTED] moved. I think his parents were getting suspect of my activities with [REDACTED]. They never said it however they got so [REDACTED] wasn't allowed to come over to my place. I saw [REDACTED] once in awhile however nothing happened.

During this time I know [REDACTED], however didn't have any relations.

I always use the same operation. It will find a kid that is like in Boy Scouts, one that is interested in radio and electronics. I gain their confidence by working out teaching electronics. Sometimes I buy radios and other electronic gear. I have helped all three of the boys get radio license. After I gained their confidence I would start talking about masturbation, I would ask if they had ever done it, and then show them how, I would either do it to them or they would masturbate me.

Going back to the relationship with _____. During most of this time we have been kissing. This would not happen before or during the sex act. We would kiss mostly for greetings and goodbyes. During the part I have laid on top of _____ and he on me. Both have tried to insert _____ into each others rectum, however it was

I was caught once, however not charged. This was at Boy Scout camp in Milwaukee. I had been having masturbation with a boy, and the camp director caught us asleep in the same bed.
