

The first letter deals with Tom Buchwalter. You say in your letter of October 17, you cannot forward the sheriff's file for him. Your earlier letter leads me to believe that you have the sheriff's file in your possession.

It has generally been the practice, over the years, that in matters of this kind, substantiating material should be kept in our files at the National office, rather than in the local council office.

The second letter I have, is your of the 19th, concerning Melvin James Whitchurch. In this case, as well as the Buchwalter case, you state that you have a case report made out by the Seattle Police Department. We feel that it would be better for that case report to be in our file in order to substantiate our refusing this man's registration in the future.

I hope that you will be able to give us additional information on both these men.
