On 29 March 1969 two members of the Committee of Troop 1034 met with Mr. James Eubank, Scoutmaster, to discuss his homosexual behavior with some of the boys in the troop. Mr. Eubank readily admitted to this "improper conduct" and resigned as Scoutmaster effective immediately.

We recommend that Mr. Eubank's name be placed on the Confidential list of the Boy Scouts of America. The committee further feels that since Mr. Eubank is taking treatment for his problem, every opportunity should be extended for his return to scouting at some future date if complete rehabilitation can be exhibited.
