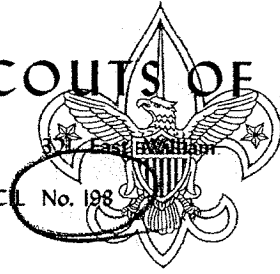

Mr. Boawe:

This is to inform you that you are no longer a leader in Troop 596. As Troop Committee Chairman, I am responsible for the leadership of the Troop. I signed your registration in February, but the situation has changed, and I no longer approve of your participation in any troop activities.

Please turn in your keys and any other materials you may have that belong to the Troop. If you have any bills due you, you will be reimbursed promptly. Take care of this during the week; it would be better if you did not come to any more meetings.

You were to have been informed personally this night, but were not here to do so. We took the liberty of "re-signing" for you; as far as anyone is concerned, your work situation does not permit you to take part.

Now, you will not take part in any more Scouting activities. You will not contact any of the Scouts in the Troop. We do not mean to infringe on any of your relationships with families of boys in the troop, but you will cease seeing boys at or between meetings.

I realize this is drastic action but the situation seems to warrant it. If you feel that you deserve an explanation I will be glad to discuss it with you but due to the circumstances I feel that I have to take this action.
