

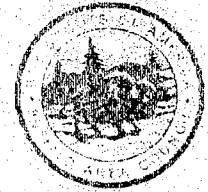

If you feel that you would like to discuss this letter with me for any reason, please do not hesitate to call me and I will be happy to talk it over with you.

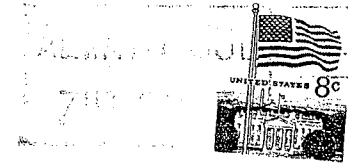
