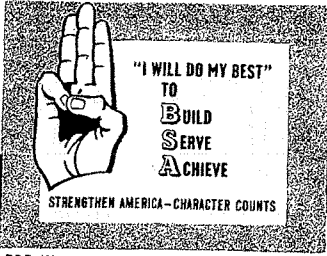

He told me everything that took place while he was there, which was quite a shock to hear.

Mr. [redacted] our Scoutmaster and Mr. [redacted] were at my home at the time and they too heard about what took place.

He immediately went to Giacalone, the counselor and confronted him with what was told us by my son [redacted]

He admitted what he had done and said, he didn't know whatever possessed him to do it. He also said, this was the first time that anything like that has happened in his twenty years of scouting.

Mr. [redacted] and Mr. [redacted] will verify these statements because they were present when the statements were made by Giacalone.

On My honor as a Boy Scout I swear that what I write is the truth.

On Friday night Feb 16, 1962 at six o'clock [redacted] and myself went to the home of Mr. Mike Giacalone, Boy Scout Afterschool counselor at 5218 The May, Detroit Mich to pass First Aid Scout Badge.

After an hour of questioning he Mr. Giacalone passed both [redacted] and I. Mr. Giacalone had a short wave receiver and he showed us boys how to tune in different countries & we discussed radios and scouting.

We left his house about 9:15. During our stay there Mr. Giacalone passed me notes asking me to come back later and he also whispered to me. I arrived home and told my parents that he had asked me to come back and my mother said okay, but to be home by

10:30, so I went back. We listened to the radio for a while and then he started putting his hand on my leg and wacking, his way up and asked me if I wanted to have some fun, that he could get it arranged. I was scared and didn't answer him. He finally took hold of my private and started rubbing it. I tried to stop him and ~~kept~~ kept pushing his hand away and he kept telling me to relax and asked me how it felt. He turned out the lights and wouldn't let me go. He tried to get me to handle his private, but I refused to and he said this is how to get a "hard on". But I was scared and it wasn't working on me. He said he had some pictures to get me going. But he never shown me them. He said he had a fellow coming over the next night and
