We appreciate very much the confidence shared with us regarding the homo-  
sexual activities of Thomas Votava. We have met with Mr. Votava and have  
secured his unconditional, immediate resignation from the Boy Scouts of  
America. We have also informed our National Personnel Division, so that  
his name can be entered in Scouting's confidential file, which will make it  
impossible for him to ever again affiliate with the Boy Scouts of America.

Because you, in essence, brought the problem to us - we are not pursuing  
this situation further with the boy's parents, law enforcement agencies, his  
employer, etc. If this is done, it should be pursued by you.

Millions of volunteer leaders give continuing leadership to the boys and units  
active in the Boy Scouts of America and, unfortunately - we do occasionally  
encounter situations such as this.

Again, we express our deep appreciation to you.

This is a summary of a conversation by Reverend [REDACTED],  
Mary Queen of Heaven Roman Catholic Church, [REDACTED],  
Cicero, Illinois, told to Joseph Koshut, District Scout Executive,  
Chicago Area Council, Boy Scouts of America, on Monday, May 17, 1965,  
9:30 a.m., at the above church rectory.

Father [REDACTED] related that a boy in the church's parochial school  
came to him with a problem on his conscience. They talked it out.

The boy [REDACTED], told of  
having homosexual contact with his Scoutmaster, Thomas Votava,  
1924 S. 49<sup>th</sup> Court, Cicero, Illinois. (Votava is Scoutmaster of  
Troop 311, Cicero School P.T.A.)

The contacts began about 1½ years ago building up to as high as  
2 to 3 contacts a week. Then about 6 months ago the contacts  
dropped off as the boy's Scouting activity lessened. However,  
the last contact occurred a month ago when the boy visited the  
Scoutmaster for a letter of recommendation.

The basic nature of the act was that of the man using his mouth on  
the reproductive organ of the boy.

These contacts took place in the man's basement.

The boy said he knew of at least one other Scout who was similarly  
related to the Scoutmaster, but would not give his name.
