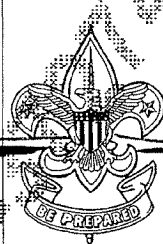



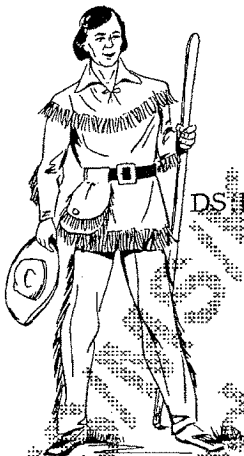
Dear Mr. Boyd:
