Subject: Dismissal of James Jackson from Semiconon Camp Staff.

During my regular visit to Camp Semiconon on August 6, 1968 I was informed by the Camp Director, Bob Slippy, that he had been contacted by Mr. [REDACTED], Scoutmaster of Troop 932, regarding a problem in relation to a problem involving Jim Jackson, a member of Mr. Slippy's staff. Mr. Slippy asked me to remain at camp until he found out the details.

Following lunch and a brief meeting with all the adult leaders in camp Mr. Slippy and I returned to the administration building where Mr. [REDACTED] and [REDACTED], a member of his troop were waiting. Mr. Slippy, Mr. [REDACTED] and [REDACTED] met in Mr. Slippy's office for about forty five minutes. I was not present.

The [REDACTED] boy was dismissed and Mr. Slippy asked me to join him and Mr. [REDACTED] when they revealed the details of the meeting to me. I suggested that we review the boy and explain again the seriousness of restrictions and ask the boy if he would be willing to put in writing the facts as he had presented them to Mr. Slippy and Mr. [REDACTED]. I was concerned about details and misunderstandings which, when finally confronting Jim Jackson might lead to arguments and doubts.

The [REDACTED] boy, age 17, is rather immature for his age even though a senior at Shaler High School. In preliminary discussion my question that "didn't he think this was unusual or improper" replied that Jackson was a camp staff member and that he did not question his intentions at the time.

[REDACTED] asked that Mr. Slippy write the statement out for him which was done. We explained again we wanted only the facts, that he would be required to give to Scout Desk that they were true, and that he would be asked to sign the statement.

Using Mr. Slippy's notes I questioned point by point the accuracy of the events until there was no doubt on the part of [REDACTED] that it was accurate.

When it was complete it was given to [REDACTED] to read and sign, to his Scoutmaster to read and witness and to again let us know if there was anything that was not absolutely correct. Mr. Slippy and myself then also witness the statement.

The boy and the Scoutmaster were then released. Mr. [REDACTED] was satisfied that the matter was handled properly and no undue pressure <sup>exercised</sup> established on the Scout.

Jim Jackson was then called in Mr. Slippy's office where he was told that we wanted him to have a statement made by one of the Scouts. Mr. Slippy then read the statement to him. He then asked Jim Jackson if it was correct and Jackson said it was except the part where he had asked to have [REDACTED] pull his pants down. (Jackson said it)

Scoutmaster [REDACTED], Troop 932 Meigsuta District in Walnut Campsite approached R. Seppy in front of the Camp Administration Bldg and said one of his Scouts had reported to him on an episode with Staff member Jim Jackson that concerned him. He said, the Scout was [REDACTED] of his Troop and he was reluctant to talk about it, but it seemed as if J. Jackson had performed a medical examination on [REDACTED]. Seppy asked Mr. [REDACTED] to bring Scout [REDACTED] to his office after lunch so that we could discuss the total matter between the Scout, Scoutmaster, and Seppy. (This was done because Seppy was at that time involved in Staff member Eric leaving Camp, Sid Richardson arriving in Camp, and a discussion with Mr. Eric, Sr, as well as the lack of time between then and lunch at 12:30 Pm)

1:15 P.M. Scoutmaster [REDACTED] and Scout [REDACTED] approached Seppy outside the Swimming Pool, after Unit leaders Coffee and dessert to tell him that Scout [REDACTED] didn't feel he wanted to come to Seppy's office to discuss the matter, because

he didn't want to get Jackson into trouble. Seppy told Mr. [REDACTED] and Scout [REDACTED] that the matter was a serious one, and although I could not make anyone answer questions, it would be necessary for me to ask some questions of the Scout, and the matter could not be dropped even if it was the desire of the Scout.

Scoutmaster [REDACTED] & Scout [REDACTED] agreed, at this point and went directly to Seppy's office.

1:35 P.M. Seppy, [REDACTED] & Scout [REDACTED] met in Camp Director's office & Seppy advised that this was a serious matter that all Scouts must further investigate, therefore even though it is a matter of getting involved, the matter must be resolved. Scout [REDACTED] was asked by Seppy of his age rank and Troop position to which Scout [REDACTED] replied he was 17 yrs of age, a life Scout, and Jr. Ass't S.M. in Troop 932. Seppy asked Scout [REDACTED] to tell the complete story of the incident, but to understand that nobody would nor intended to make him report further, this he must decide and do as a Scout.

Scout [REDACTED] reported the following with occasional clarification by S.M. [REDACTED].

Scout [REDACTED] had first notified his S.M. of the incident at about 11 A.M. Tuesday Aug 6, 1968

my first contact with Jim Jackson this week was after lunch on Monday 8-5-68 as I was walking from the Dining Hall with Troop 932 past Beechnut Campsite (SPC Site) when Jackson asked me to come up to his campsite. He then asked me if I was married and if I was a football player and asked me to come back and see him at 10:00 that night at his campsite.

10:00 P.M. (Jackson's Tent)

Jackson asked what sports I liked and if I was interested in being on the Camp Staff. He said I should be a football player with my build. Jackson said he was a medical student at Pitt and never giving any other reason asked me to take off a shoe and sock, & then my other shoe & sock and felt my feet and ankles. He then asked me to open & pull out my shirt & he felt my ribs & back. Then he asked me to take off my pants and underpants & left the tent for a minute, when he returned he again told me to take off my underpants and lay down on his bed, which I did. He said he was testing me and felt my chest and back, & stomach and my penis. He also inserted his finger into my rectum, with some kind of salve on it. Then Jackson told me to get dressed which I did. While I was putting on my shoes

He told me to pull down his pants - I said no! Jackson then told me to leave at about 11:00 P.M. and asked me to come back on Tuesday, but I said no, because my parents were coming to visit me Tuesday. He asked me to try to come Tuesday afternoon. I went back to my campsite.

At Breakfast Tuesday Jackson asked me again to see him at his tent sometime Tuesday afternoon.

Scout [redacted] told his Scoutmaster [redacted] about the incident, although not in detail, at about 11:00 A.M. Tuesday, August 6, 1968. Mr. [redacted] went to see Jackson at his campsite at about 11:30 A.M. Tuesday because of a request Jackson had made that they discuss how another Scout had done, from his Troop, the week previous in SPC training. Jackson gave Mr. [redacted] some copies of the material used for SPC training, ~~and~~ the subject of Scout [redacted] never was mentioned. Except Mr. [redacted] told Jackson, [redacted] would probably not be interested in the Camp Staff, but it would be up to him to decide.

At 2:30 P.M. Seppy asked Scout [redacted] to stand by outside his office & invited Sid Richardson to join he & S.M. [redacted] at which time Seppy reviewed his notes and [redacted] & Seppy filled in Richardson on the events occurring to that time. Richardson indicated there was only one way to resolve and handle the matter with such a serious accusation of J. Jackson. This would require the Scout ([redacted]) to write out and sign a factual statement of his own free will in the presence of Richardson, Seppy, and [redacted]. This was agreed as the plan to pursue & [redacted] brought Scout [redacted] back into the office. Seppy and Richardson advised [redacted] of his responsibility as a Scout to help in this matter but emphasized he should only do so if he felt it was right to do and realize there was no pressure on him to do so. Scout [redacted] agreed he wanted to do what was right and consented to signing the statement as written by Seppy in the presence of and reread by Scout [redacted], S. Richardson & [redacted]. Richardson advised the Scout & Scoutmaster that he & Seppy would now read the statement to Jackson and ask him if it was true or not - that they were to stay in the area but go about their normal

Camp routine.

3:20 P.M. Seppy called J. Jackson into his office with S. Richardson and advised Jackson he had a serious signed statement to read to him after which Jackson would have an opportunity to speak.

Seppy read the statement to J. Jackson, in the presence of S. Richardson. J. Jackson said "it is true, except for the part where I asked him to pull down my pants - I don't know what got into me"

Seppy and Richardson advised Jackson he would have thirty (30) minutes to pack his personal gear and be out of Camp. That he would go home with Mr. Richardson & a Staff member would be with him until he left Camp. He was told to present his Scout registration card to Seppy before leaving Camp and that he could no longer be registered with the BSA or hold a position in the Camps, or Council, or Scouting.

3:30 P.M. Seppy told Ass't Camp Director Don Braman to escort Jackson to his tent, stay with him while he packed

his year and take hand his year to Richardson's car.

S. Richardson then, in Seppy's presence, called George Cahill, S.E. and advised him of the incident. Richardson told Seppy of Cahill's suggestion that S.M. [redacted] personally go & see the father of Scout [redacted] about the incident.

4:00 P.M. Jackson presented his Registration Card to Seppy at Richardson's car, in presence of D. Bhaman & S. Richardson. His year was put into Richardson's car & they departed. (They being Richardson & Jackson)

6:00 P.M. Seppy talked with Scoutmaster [redacted] and advised him of suggestion to visit Scout [redacted]'s father as well as the action taken with J. Jackson at 4:00 P.M. [redacted] & Seppy agreed they would look visit Mr. [redacted] that evening and agreed to meet at the parking lot at 8:30 P.M. Tues evening 8/6/68 in uniform to go to Etna to see Mr. [redacted]

6:40. Seppy announced to Camp staff that Jackson had left the Camp staff for personal reasons & would not be back

8:30 P.M. [redacted] & Seppy left Camp Senicomon in Seppy's car for Etna, not having called Mr. [redacted].

Mr. [REDACTED] called Mr. [REDACTED] from payphone along route #8 about 5 miles north of Etna & found he was at an Elks meeting, the same Elks that sponsor Troop 932. Slippy & [REDACTED] proceeded to Etna Elks Lodge 932 & waited for Mr. [REDACTED] to come out of his Lodge meeting, where he was serving as Secretary.

At approximately 10:10 P.M. Mr. [REDACTED] & Mr. [REDACTED] of Slippy met in a private room at the Elks. Slippy congratulated Mr. [REDACTED] on having a son who at age 17 had the guts to get involved in a solution and to report & follow thru with it. S.M. [REDACTED] explained the incident, without details, and the dismissal of 'J Jackson. Slippy told Mr. [REDACTED] he had no present knowledge of any intended further action against Jackson.

Mr. [REDACTED] thanked us for the way the incident was handled & for coming to see him — brought us a Coke & we departed to return to Semicon. Mr. [REDACTED] was well satisfied in my view.

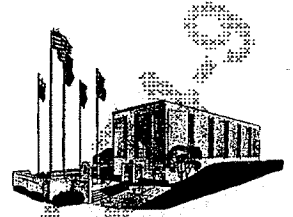


