We have investigated a charge that Mr. Jerry Bailey, Scoutmaster of Troop 147, had been asked to resign from the Duval County Parental Home for Negro Boys in December 1960 for fondling boys under his supervision and found the facts to be true.

After reporting the results of this investigation to our Chairman, Dr. J. C. Downing, he asked that we write you recommending that Mr. Bailey be relieved of his post as scoutmaster in order to protect the boys in his troop and the good name of scouting.

We trust that your office will handle the matter in a tactful manner.

Dear Mr. Bailey:

Recent charges have been made by eight (8) boys here in the Home of your fondling them at various times here on the grounds. In regards to the character of the children who are involved, the reported tactics which were used by you to seducing them cannot be excused.

It was reported that threats were made by you to the boys of bringing a boy to the office for engaging in homosexual acts among themselves. Instead of actually bringing a boy to the office to answer to the accused offense, he would be carried to his individual room or a bathroom and subjected to abnormal demonstrations in your presence. Identical charges were made by most of the boys involved. If you found any boy involved in homosexual practices it was your duty to report any immoral acts to the office. Your failure to do so is a serious mistake. The boys involved cannot be excused for their part in these practices nor the act condoned; as an adult your responsibility is greater. The act is regrettable and unfortunate.

In view of the circumstances, you are kindly requested to submit your letter of resignation effective December 9, 1960, end of work day. Resignation will be effective December 16, 1960.

May God help you in future adjustment.
