Larry Pegg, our district scout Executive, has requested that I inform you of a series of incidents which are alleged to have occurred in the recent past. They concern Richard F. Lindenmuth, 514 N. 4th St., Allentown, Pa.

A few weeks ago the Bethlehem Police Dep't notified us that they had arrested Mr. Lindenmuth on a morals charge which involved a nine year old girl named [REDACTED], Bethlehem, Pa.

Questioning of the girl revealed that a similar indecent act had occurred when the girl and her family lived in Allentown last year. Consequently Det. Chas. Schaffer of the Allentown P.D. is charging Lindenmuth with Statutory Rape. Lindenmuth, for lack of a bail bond, is incarcerated in the Lehigh County Prison.

It is suggested, of course, that Lindenmuth be dropped from BSA roles now and hereafter.

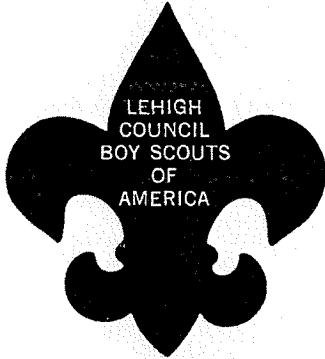

Delay Granted In Morals Case

A 36-year-old Allentown man had his hearing on a series of morals charges continued by Allentown Alderman Thomas M. Miller.

Richard Lindenmuth of 512 N. 4th St. was recommended by Lehigh County Board in default of \$3,000 bail after the adjourned hearing.

He is charged with sodomy, statutory rape, continuing the morals of a minor and indecent assault.

Miller said the charges involve a 9-year-old girl.

Lindenmuth was arrested by Allentown police.
