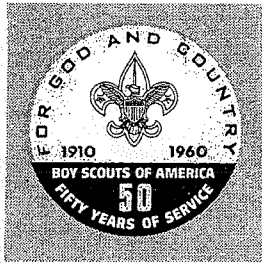

This is to report a sex offender who is now registered in our Council.

Case broke June 27, 1960
Person: Rev. Dean Jones, Pastor Christian
Church, Memphis, Missouri
Scouting affiliation: Cubmaster

Mr. Jones was specifically charged by a mother of "Oral Sodomy". This happened at a meeting of the church board with the mother, the pastor and the boy present. He failed to deny or admit it but immediately resigned his position in the church. The next day he went to the Bloomfield, Iowa hospital to visit and presumably threw a fit, and is now a patient.

Other unconfirmed stories have come out since, of attempted molestation of girls at a church school, approaches to older boys who immediately quit the church. Affair with a high school girl while his wife was in the hospital.

The present charge may or may not go before the courts, but sufficient evidence has been collected to verify the major complaint.
