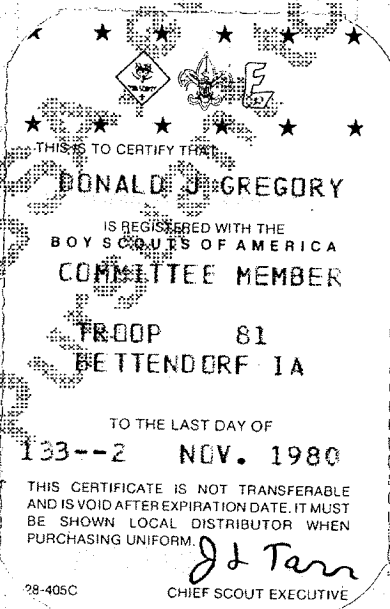

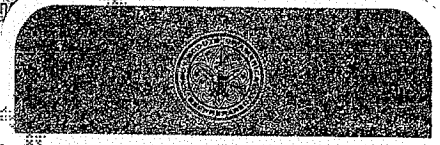

Former Cubmaster of 3240, sponsored by Salvation Army in Rock Island.

Presently registered as Assistant District Commissioner for Cub Roundtables in Chief Blackhawk District.

Background:

Reported to Illowa Council by Region 7 office - the aforementioned individual was a suspected homosexual.

Action:

A contact was made with [redacted], Director of Personnel at the Corps of Engineers, Rock Island. Don Gregory was employed as a warehouse man there. Mr. [redacted] indicated that he was a good worker, and they had no trouble with him. After the routine investigation was conducted, there was a confrontation with Don Gregory, and he resigned. Mr. [redacted] gave verbal confirmation that this man indeed had homosexual tendencies. There is no record in Rock Island because he has been shipped to Washington, D. C. as prescribed by law.

A contact was made with Captain Roy McGuire of the Rock Island Police Department. He assigned Lt. of Detectives Jackson to investigate the record of Don J. Gregory. The following is a report of the record:

Don Gregory has been questioned by the Rock Island Police regarding a complaint of Indecent Exposure in front of the Y. M. C. A. Mr. Gregory reported that he did indeed often park by the Y. M. C. A. but only because he ate in a cafe two blocks away.

An informer related to the Rock Island Police Department that Don Gregory was indeed a homosexual and did molest boys in the age group of 10 to 16.

There has been no arrests or convictions recorded.

Lt. Jackson said he would be glad to talk to the man if we wanted him to.

Conclusion:

No doubt Don Gregory is a homosexual.


Dear Paul:
