Dear Mac:

On your recent Transmittal No. 48 you included an Additional Enrollment for Troop 66 on which you listed Arthur F. Clark as a Committeeman and Hunter M. Bugg as Scoutmaster. Unfortunately, there are two problems in connection with this that prevent our accepting their applications.

First of all, you placed Arthur F. Clark with us in a confidential capacity late in September of this year. As a result of your earlier report to us, he has already been deleted as Scoutmaster, and we are unable to accept his registration in any other capacity.

The second problem is that when Bugg was registered in March of 1965, on the reregistration papers he was listed as being only 19 years of age. If this was accurate, he couldn't possibly now be 21 years old, and so we must hold his new registration until we receive clarification regarding his age. We will hold the additional enrollment pending until we hear further from you.

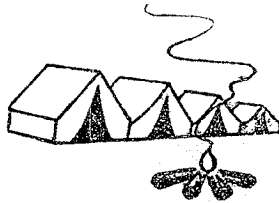

It was then I reached the decision confront me (Commissioner [redacted] about the situation that took place at my camp site. Then I felt that this would be the best way for the situation to be handled, due to the fact that the scouts were of minor classification in age. I have know both boys prior to entering my Troop and especially the scout directly involved. I know that both boys do not suffer from any apparent emotional problems. I know them not to be scouts who would wilfully lie or place someone in trouble. I will inform the parents personally of the incident upon returning to the city. I will arrange a meeting with Camping Director Dave Burkalin upon his return to the city. I am satisfied with the way things have been handled thus far. I also cautioned the two scouts involved not to discuss this with other members of the troop or outsiders.

A meeting was scheduled at the camp office with the scouts involved and their scoutmaster, Program Directors and the Director of Camping.

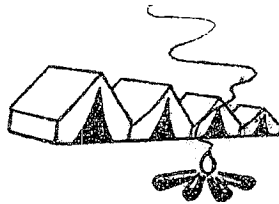

WILLIAM COVINGTON: SCOUTMASTER

The above stated that he knew John Doe from seeing him around the neighborhood in the city, and remembered that they attended school together years ago. The second day in camp I invited him to my campsite, after making him aware that I knew him from school and the old neighborhood. I suggested that he come down and give the boys a pre view of scouting and pep talk, and in reference to Merit Badges. He did not come to my site until Tuesday night about 9:50 P.M. (I am referring to site 5) Upon his arrival he came to my leanto, at which time I was distributing cake to my scouts. I think that is when he saw one of the scouts involved. He sat and talked with me for about five or ten minutes, then he proceeded to go from tent to tent talking to different scouts, which I thought nothing of. I then left my leanto and proceeded to go from tent to tent collecting flashlights. I did this because the night before the boys did not go to sleep on time because they shined the lights up and down the area. I passed a tent in which he was (John Doe) sitting talking to two scouts. I didn't take their flashlight because of the fact he was there holding conversation. I then returned to my leanto and held a Green Bar Meeting. At which time, the close of my Green Bar meeting, I looked out and saw that all lights were out. To my knowledge I did not know when or what time he left my site. Then about 11:15 or 11:30 P.M. The two involved scouts awaken me, and told me that the Camp Counselor, who visited them had done something they thought was out of place. I proceeded to question them as to what went on; it was then they told me that John Doe had taken his hand and proceeded to put it inside one scouts pants. This was repeated several times and in one instance he took the boy's hand and placed it upon his lower part of his privates. The scout stated he with drew his hand only to have taken and placed there again. John Doe then told the other scout to turn off his flashlight and after several minutes of repeat performance of the above mention incident, the scout then mention that he was sleepy and wish to go to bed. It was then and only then that John Doe, decided to make his exit. To my knowledge I did not know what time he departed my campsite. I was hesitant to report this matter, because I did not want to involve John Doe, until I was sure that the incident had taken place. I questioned them three or four times separately and together and their story did not change from the first one that was told. I observed the scout who was directly involved doing the day and he refused breakfast and did not want to leave the campsite. I spoke to him again about the incident and I saw that he was so emotionally upset that I thought it was better that I report it to someone. I spoke to several other leaders about how I should handle this, do to the fact that it was my first time at Hart with a Troop.

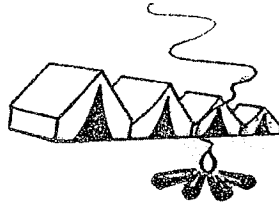

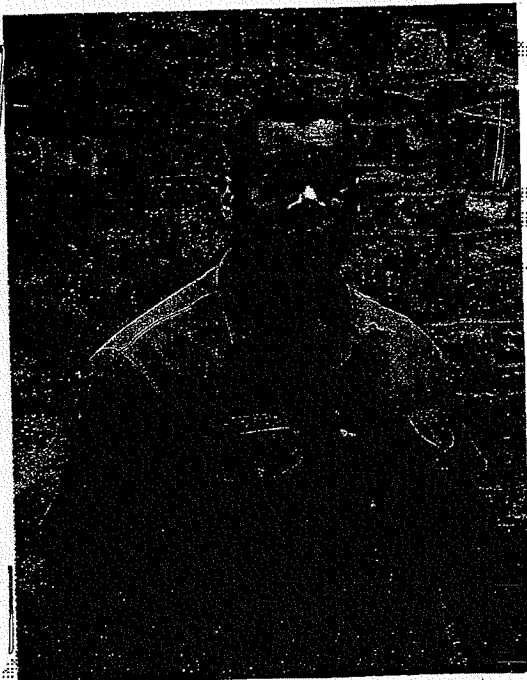

The below named camp staff was involved in the investigation of the incident reported West Program Director, East Program Director, Sr. Commissioner and Director of Camping.

We did interview the scouts involved, and obtained basically the same facts that was related by the scoutmaster. The scouts also told us that before the lights were turned or order turned out by John Doe, he was pulling on the youth and laying his head against his body. When the youth moved he was pulled back to the cot again both boys tell this story. When the second scout continue to watch with his light on he was told to turn his light out which he did and he heard movements and could just see the pulling in the dark. Camping Director has all of the other facts.
