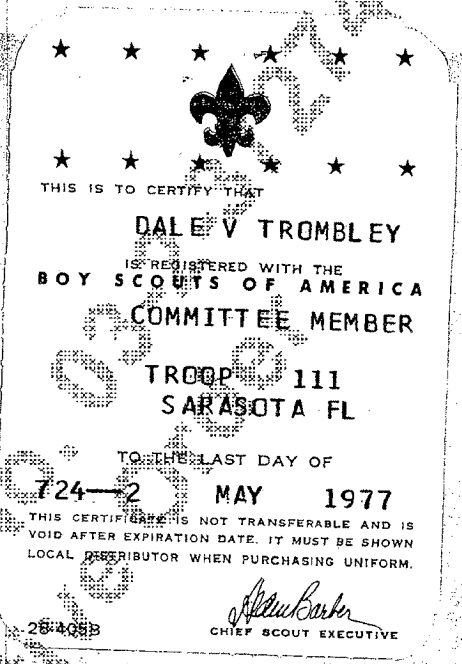

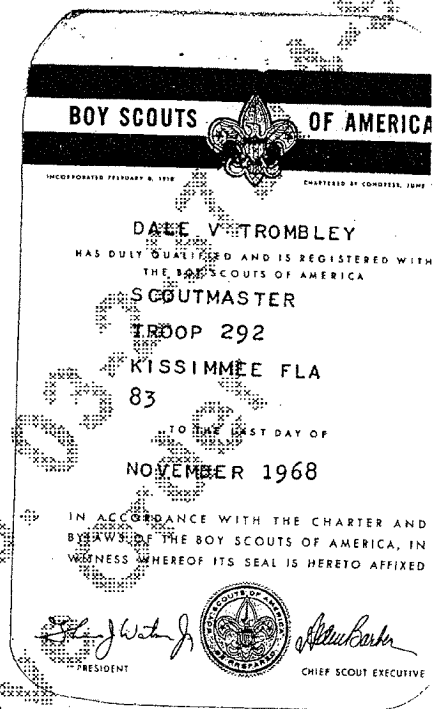

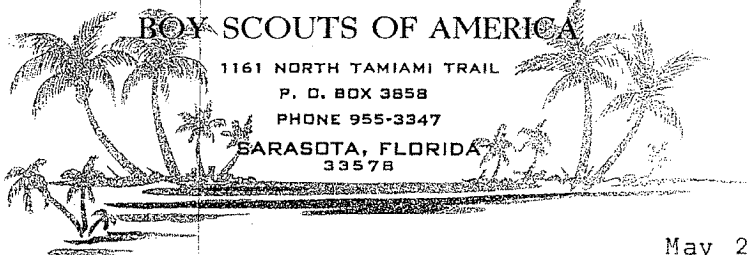

STATEMENT

A mother called and said that Mr. Trombley had been coaching her 10-year-old son on Tenderfoot requirements for Boy Scouts. He had asked to take the boy over to his apartment so that there would be less interference from other children in the boy's home. The mother was concerned. She was advised not to allow the boy to engage in this activity. Trombley was greeted by the boy's father that evening and run off the property after some harsh conversation.

Trombley transferred his Scout activity to another community and got involved in a similar situation in that community also. Inquiries by this office revealed a history of suspicious activity by his former employer and employees and minister of his church.

Trombley was invited in for conference and admitted homosexual activity and that his doctor had advised him to stay away from young boys that he was a "potential electric chair" case. Roy Henderson was invited into the conference for verification. This man admitted that he had been but he is now cured of homosexual tendencies. He continued to admit, however, that he could not keep himself out of difficult situations with boys and their parents that at anytime he would break. Both Mr. Henderson and I advised him to resign all positions in Scouting. He tendered his resignation as Scoutmaster and moved to Sarasota, Florida.

ADDITIONAL DETAILS OF OFFENSE, PROGRESS OF INVESTIGATION, ETC.

4/9/65 - Before this complaint came in, the subject DALE TROMBLY w/m approx. 24 years old, 916 Highland Drive, Sarasota or 2401 32nd St. W. was taken in Troop 63 Boy Scouts of America as Asst. Scout Master.

After certain old occurrences with Trombly, [REDACTED] and I decided not to leave Trombly with any of the Scouts by himself. After a few weeks, we started to find out that he was always buying candy and ice cream for the boys around 11 or 12 years old. He always wanted to pick the boys up from home to take them to Troop Meetings or other places, and then bring them home again, which didn't seem just right. Then, conversation was overheard by a couple of the boys and they were questioned further into what was said and this is what, according to most of boys in Troop and boys outside the Troop he has associated with in an Archery Club, Skindiving Club he has tried to start. He has told them certain things and bought them certain things and then would see if they told their parents about receiving the items. If they didn't, then he would swear them to secrecy and then tell them about his masturbating machine he said he made and about sex pictures he had, but none of the boys I talked to have ever seen the machine or pictures. He would tell them stories about taking out a girl that works in the bank in Sarasota and describe the actions that would occur.

As far as I can find out, he has never dated a girl. He is always around boys in the age group of 10-13 years. As far as the boys are concerned, he has never made any advances with his hands or offered in any way to touch any body of the boy.

At this time, the subject has not been brought in for questioning.


