I am Ralph P. Dyson (DYSON) last with Boy Scout Troop 40, Wabash District, Michigan Council, Marion, Indiana (Region 7). I was, as I understand it, "dropped" as an eligible Scoutmaster because of an arrest on a felony charge (namely, undesent exposure). I was accused, convicted and sentenced before being arrested. God as my witness I was not guilty of these charges. As I remember this occurred in the fall of 1963.

Having been in Scouting for some 17 years I am asking your advice in this matter so I can continue my service if possible.
