Regarding: Red Flag List

John A. Tillman, 1852 Cloverdale Avenue, Highland Park, Illinois was registered as Assistant Scoutmaster with Troop 30 sponsored by the First United Evangelical Church of Highland Park from January 1956 to January 1961.

On October 23, 1960 he was involved in a complaint alleging sex offenses and was charged with contributing to the delinquency of minors. We are enclosing herewith a letter from the Chief of Police of Highland Park informing us that he was found guilty and fined, and placed on probation.

When we were informed of the situation we requested that his connection with Troop 30 be discontinued and he is not now active with Scouting in the North Shore Area Council. We feel, however, because of the situation he be placed on the red flag list and permanently disqualified to serve in a position of leadership in Scouting.

Dear Mr. Schwechel:

This letter is an official follow through on several conversations between Dan Milzer and myself concerning John Adcox Tillman, 27, 1852 Gloverdale Avenue, Highland Park, Illinois.

John Tillman has been an Assistant Scoutmaster for [redacted] here in Highland Park for a couple of years. On 23 October 1960 we received a complaint alleging sex offenses occurring on our beaches and that several juvenile girls were involved with an adult male. One of these girls was the daughter of [redacted] and during an interview, she involved John Tillman. During interrogation John Tillman admitted being sexually involved with several juvenile girls. He was charged with Contributing to the Delinquency of Minors. After numerous continuances he was tried in the County Court by Judge Minard Hulse, found guilty, fined \$200.00 and costs of \$75.00, and placed on two year's probation.

Dan thought you should have this information for your files due to Tillman's connection with Scouting.
