Dear Mr. Wilson

In regards to Bob Pine activities while on the adult staff of Camp Thunderbird, Tumwater Area Council:

We were conducting a week-long Jr. Leader Training Course at Camp, and Bob was to become an Assistant Program Director with us this summer, so he was assisting us with the program this week of June 13 - 20, 1965.

Bob would ask a boy if he wanted to go on a nature hike and then when away from the group, would start wrestling with them and end up playing with them. His other approach was to ask a boy to go swimming, and in such a hurry that the boy was instructed to bring his swimming suit along and change later, and when the boy was changing, he would start wrestling playfully, then start assaulting them. He worked this three times each, that we know of for sure.

We found out about these acts as one boy was telling another and a staff member overheard them and reported it to me, the Camp Director. When I investigated, I found the boys scared to talk because they were afraid Bob Pine would beat them up. We also found out that this had happened within the troop he was working with before camp.

He claimed to be a student at Texas Western and to have grown up in San Diego, California. He was in Hawaii before coming to this area in early March, 1965. While here, he lived with a friend by the name of Dr. Lyman A. Fleetwood, dentist, and found work as part time help with the Lacey Fire Department. We found out later that he had been asked to leave because of a run in with other boys of college age.

He claimed to have worked in YMCA camps and Boy's Club Camps before, but we never checked his references. He was always mentioning that he would be a good person to take the boys on a canoe trip or hike, and could not understand it when we said that was a Unit leadership responsibility.

When I fired him and took him to town, he admitted being a queer. I asked him why and he shrugged his shoulders and the look on his face was that of a kid with his hand caught behind the candy counter.

This is all I know of Bob Pine, and hope that this is the information you need.
