Anderson was acquised of sodomizing a 16-year-old boy in the school superinten on Feb. 26, 1990. The school superinten dent, Darrell Brite, walked in while the moleciation was occurring, according to a police research Anderson immediately resigned from his post at the school as chief custodian.
