

Please find enclosed the "Ineligible Record Sheet" for a Mr. Michael John Bahaus. In addition, I have enclosed the criminal records of this individual. Mr. Bahaus has a record of child molestation. On May 13, 1991, our office received a phone call from a neighbor of Mr. Bahaus. She told us that "Scouts" were seen with Mr. Bahaus. She felt that she needed to warn us that this individual had a record of child abuse. Our search discovered Mr. Bahaus was working with Troop 133, sponsored by Christ United Methodist Church. He had not been registered. The Scoutmaster was told to remove this individual. I met with the Troop leadership in order to determine if Scouts had been molested. To date, we do not have knowledge of Scouts molested by Mr. Bahaus. If this problem arises, we will inform BSA.

After careful review, we have decided that your registration with the Boy Scouts of America should be denied. We are therefore compelled to request that you sever any relations that you may have with the Boy Scouts of America.

You should understand that BSA membership registration is a privilege and is not automatically granted to everyone who applies. We reserve the right to refuse registration whenever there is concern that an individual may not meet the high standards of membership which the BSA seeks.

If you wish to have this decision reviewed by a BSA regional review committee, please write to the regional director within 60 days of the date of this letter, explaining your version of the facts supporting your claim that your registration as a BSA member should be granted. The procedures for a review of this decision are attached.

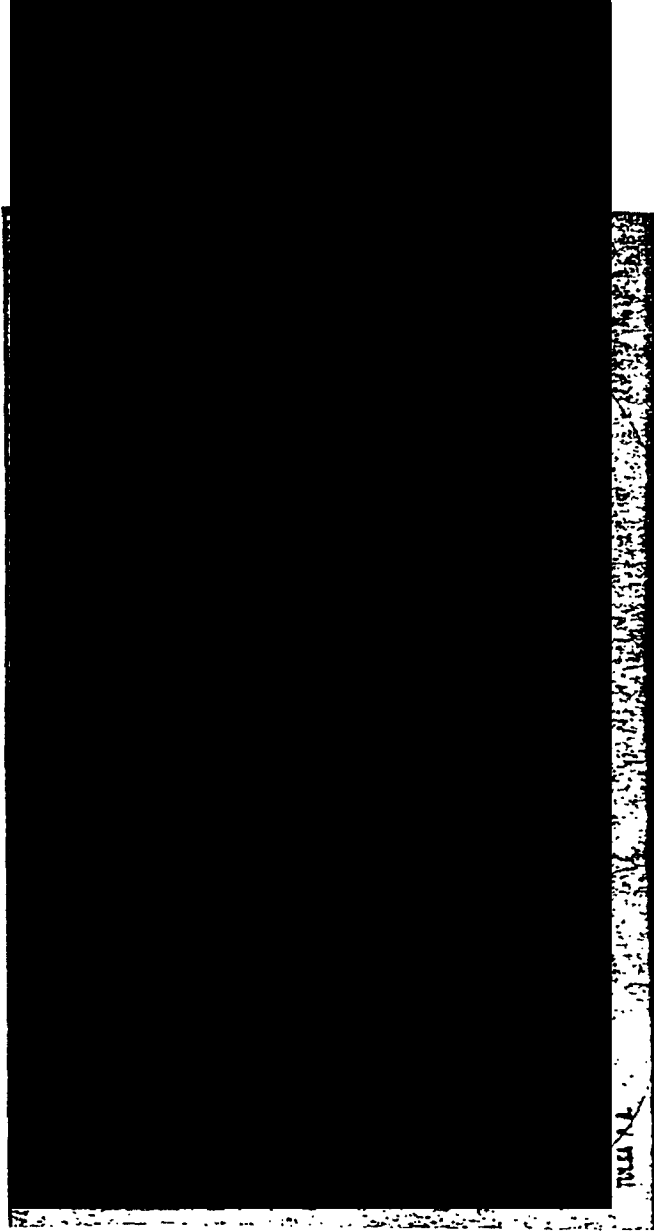

## DETAILS:

On Wednesday, 04/10/85, the suspect, Michael Bauhaus, came to the Detective Division to discuss the above case. Immediately, I advised him of his rights and he signed a Certificate of Notification of Rights TUL Form 1229A. We then began discussing the case. He first gave a taped statement admitting to everything with the exception of the sexual acts. Suspect then confessed to the sexual acts, giving me names of the persons in which he had had anal intercourse and oral sodomy with, including the victim in the above case. The confession was tape recorded and the tape will be turned into Barbara Gifford, Stenographer, for transcription at a later date. It will subsequently be turned into Property Receipt No. RS881. After completing the taped confession, I made a telephone conference with Assistant DA, Fred Morgan, in reference to the above case. Suspect was then placed under arrest and booked on the above charge of lewd molestation to a minor.
