
I have not forgotten the letter that you sent me on Jeffrey A. Bartlett.



Dear Sir :

The committee of Troop 49 met this past Monday night, the 24th of November, with Scoutmaster Jeffrey Bartlett. Mr. Steven Dunphy of the BSA was also present. At the completion of the meeting it was agreed upon by Mr. Bartlett and the troop committee that, for the best interests of both parties, he would be as of 11/25 on a leave of absence as Scoutmaster of Troop 49. This would remain his status until his legal problems with the State of R.I. are completely resolved.

The committee also stated its complete backing and faith in favor of Mr. Bartlett in his legal problems. Several committee members stated a willingness to be character witnesses if asked. The committee also made it clear that Mr. Bartlett is welcome at all adult committee meetings. We felt he should know what is happening with his troop and also he could keep the committee abreast of his personal progress.
