## Payette man's sentencing set

PAYETTE (UPI) — A former member of a regional advisory committee on youth in Payette has pleaded guilty to a felony charge of lewd conduct with a 12-year-old boy.

Don Belmer, 43, of Payette is scheduled to be sentenced Dec. 2 in 3rd District Court following his plea Friday.

Payette County Prosecutor Bruce Birch said he expects Beimer to be placed on probation and ordered to take part in a treatment program for sex offenders.

The unmarried Belmer, a long-time foster parent, was accused last month of sexually abusing a boy who was staying at his home during a visit last summer.

Birch said Beimer has no prior record and is a good candidate for rehabilitative counseling.

Beimer has been honored for his work as a Boy Scout leader and served as chairman of the Payette County Youth Accountability Board, a community-based program for first-time juvenile offenders.

Belmer's lawyer, LaMarr Kofoed of Fruitland, said his client has been receiving counseling since his arrest and has cooperated fully with authorities.
